- Activity Code or NTEE Core Code (if applicable for organizations related to arts/humanities)

- Certificate of Good Standing from NE Secretary of State ***
- Employer Identification Number (EIN)
- Internal Revenue Code Section 501(c)(3) Letter ***
- o Articles of Incorporation and or By-Laws (demonstrating the purpose of the organization) ***
- o IRS Form 990 from 2020-2022 ***
- o 2020-2022 Income Statements, Cash Flow, and Balance Statements ***
- Financial procedures handbook or any other document that outlines the Applicant's established financial policies and procedures ***
- Most recent financial statement audit and/or single audit *** (Include any corrective action plans associated with the audit. If there is no audit, upload a statement to that effect) ***
- Federal or state program audit reports and associated reports that demonstrate minor to no findings (if no audit, upload a statement to that effect) ***
- Evidence of Board Approval for grant request and authorizer contact information ***
- Applicant's internal accounting/financial procedures including, but not limited to, identification of the type of accounting system used to track federal and non-federal transactions, allocation of transactions, and system of accurate record keeping and expense tracking
- Applicant's ability and history for the management of state or federal grants of equal of similar size and complexity as the one being requested, if any
- Applicant's written policies and procedures to implement changes in laws, regulations, guidance, and funding agreements affecting federal awards and programs
- o Applicant's policies and procedures for sound financial management
- Applicant's experience with complying with statutory, regulatory, or other requirements, with examples, as it relates to state or federal grants

- Documents related to the capital project (e.g. renderings) ***
- Documents related to the economic impact of your capital project ***
- o Information related to the project delayed by COVID-19 (if applicable)
- Capital project location address
- Proof of organization's capital interest in project location (e.g. land ownership, use agreement, lease document) ***
- o Amount of grant funding requested
- Total capital project cost
- o Match amounts secured by pledge, payment and unsecured
- Match ledger sheet, download from website ***
- Award budget (grant and match funding allocations for amount of award requested and equivalent match for <u>eligible costs</u>; do not include total project cost on the <u>award</u> budget)
