These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by the Nebraska Department of Economic Development, the grant recipient, and also the Responsible Entity (RE).

REQUEST FOR RELEASE OF FUNDS

On or after April 22, 2025, the Nebraska Department of Economic Development will submit a request to the United States Department of Housing and Urban Development (HUD) for the release of HOME Investment Partnerships Funds (HOME) program funds under Title II of the (Cranston-Gonzalez) National Affordable Housing Act of 1990 (42 U.S.C. 12701 et seq.), as amended, to undertake a project known Whitetail Villas for the purpose of a proposed new construction of a 20-unit rental housing project to be occupied by the general population in Schuyler, Colfax County, Nebraska. The project will be built in duplex design and consists of 20 single story, two-bedroom rental units (ten buildings). The 2 Bedroom units will have 998 square feet of living space in each duplex unit. All units in Whitetail Villas will include 3kW of Solar. The units also have an attached garage, garage door opener, storm shelter, washer, dryer, range, refrigerator, dishwasher, garbage disposal and microwave. Lawn care, snow removal, and trash will be provided and paid for by the project.

Project will adhere to the (federal Internal Revenue Code) Section 42 Low Income Housing Tax Credit (LIHTC) Program. Four of the units will be HOME Investment Partnerships Program ("HOME") floating HIGH HOME units occupied by tenants at or below 60% AMI (area median income). There will be no displacement of residents, business, or farms.

Mesner Development Co. of Central City, Nebraska is the Developer of the project. Schuyler Community Development Inc. will be the Managing Member of Whitetail Villas, LLC, the ownership entity of the project. Schuyler Community Development Inc. will also be the Management Agent as well as have the Right of First Refusal to purchase the property at the end of the 15-year tax credit compliance period. The investing member of LLC will be Midwest Housing Equity Group.

The total project cost is \$5,350,944. Of this amount, \$650,000 will be funded with HOME funds, \$2,943,130 will be funded with Federal Low-Income Housing Tax Credit equity, \$1,297,814 will be funded with State Affordable Housing Tax Credit equity, \$65,000 will be in the form of Owner Equity, and \$395,000 will be in the form of a conventional first mortgage.

All of the units are handicapped, adaptable and will meet visitability standards. One unit will meet all Uniform Federal Accessibility Standards (UFAS) requirements for accessibility. One unit will meet the visual/hearing impaired requirements. The land is currently vacant. There will be no displacement of residents, businesses or farms. Project will be completed within 24 months.

FINDING OF NO SIGNIFICANT IMPACT

The Nebraska Department of Economic Development has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to the Nebraska Department of Economic Development. All comments received by April 21, 2025, will be considered by the Nebraska Department of Economic Development prior to authorizing submission of a request for release of funds. Comments should specify which Notice they are addressing.

ENVIRONMENTAL CERTIFICATION

The Nebraska Department of Economic Development certifies to HUD that Joseph Lauber in his capacity as Deputy Director, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. The HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the Nebraska Department of Economic Development to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of fund and the Nebraska Department of Economic Development certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the Nebraska Department of Economic Development; (b) the Nebraska Department of Economic Development has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) to HUD's email address at CPD_COVID-190EE-OMA@hud.gov. Potential objectors should contact HUD via email to verify the actual last day of the objection period.
