

LEGAL DESCRIPTION

A TRACT OF LAND LOCATED IN THE NORTHWEST QUARTER OF SECTION 20, AND TOGETHER WITH A PART OF THE NORTHEAST QUARTER OF SECTION 19, ALL IN TOWNSHIP 15 NORTH, RANGE 11 EAST OF THE 6TH P.M., DOUGLAS COUNTY, NEBRASKA BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

THENCE ON A 80.00 FOOT RADIUS CURVE TO THE RIGHT, AN ARC LENGTH OF 36.14 FEET (LONG CHORD BEARS N42°21'43"W, 35.84 FEET) TO A POINT OF REVERSE CURVATURE; THENCE ON A 37.00 FOOT RADIUS CURVE TO THE LEFT, AN ARC LENGTH OF 29.27 FEET (LONG CHORD BEARS N52°04'40"W, 28.51 FEET); THENCE N00°25'16"W, 49.94 FEET TO A POINT OF CURVATURE; THENCE ON A 39.00 FOOT RADIUS CURVE TO THE LEFT, AN ARC LENGTH 34.11 FEET (LONG CHORD BEARS N60°00'14"E, 33.03 FEET) TO A POINT OF REVERSE CURVATURE; THENCE ON A 78.00 FOOT RADIUS CURVE TO THE RIGHT, AN ARC LENGTH OF 18.87 FEET (LONG CHORD BEARS N41°52'43"E, 18.82 FEET) TO A POINT OF REVERSE CURVATURE; THENCE ON A 39.00 FOOT RADIUS CURVE TO THE LEFT, AN ARC LENGTH OF 33.10 FEET (LONG CHORD BEARS N24°29'45"E, 32.11 FEET); THENCE N80°44'18"E, 48.78 FEET TO A POINT OF CURVATURE; THENCE ON A 37.77 FOOT RADIUS CURVE TO THE LEFT, AN ARC LENGTH OF 31.87 FEET (LONG CHORD BEARS S42°24'54"E, 30.93 FEET TO A POINT ON THE EAST LINE OF SAID NORTHWEST QUARTER, THENCE ON SAID EAST LINE OF THE NORTHWEST QUARTER S02°55'33"E, 325.40 FEET TO A POINT OF CURVATURE; THENCE ON A 335.00 FOOT RADIUS CURVE TO THE RIGHT, AN ARC LENGTH OF 262.56 FEET (LONG CHORD BEARS \$19°31'37"W, 255.89 FEET); THENCE \$41°59'04"W, 114.71 FEET TO A POINT OF CURVATURE; THENCE ON A 335,00 FOOT RADIUS CURVE TO THE RIGHT, AN ARC LENGTH OF 180.75 FEET (LONG CHORD BEARS S57°25'59"W, 178.56 FEET; THENCE S03°01'29"E, 10.07 FEET; THENCE N86°58'31"E, 333.90 FEET TO A POINT ON THE EAST LINE OF SAID NORTHWEST QUARTER; THENCE ON SAID EAST LINE OF THE NORTHWEST QUARTER S02°55'35"E, 1215.09 FEET; THENCE ON THE SOUTH LINE OF SAID NORTHWEST QUARTER S87°12'55"W, 2641.52 FEET TO THE WEST QUARTER CORNER OF SAID SECTION 20; THENCE ON THE SOUTH LINE OF SAID NORTHEAST QUARTER OF SECTION 19 S86°59'43"W, 1325.05 FEET TO THE SOUTHWEST CORNER OF THE SOUTHEAST QUARTER OF SAID NORTHEAST QUARTER OF SECTION 19; THENCE ON THE WEST LINE OF SAID SOUTHEAST QUARTER OF THE NORTHEAST QUARTER N02°59'15"W, 1322.62 FEET TO THE NORTHWEST CORNER OF SAID SOUTHEAST QUARTER OF THE NORTHEAST QUARTER; THENCE ON THE SOUTH LINE OF THE NORTHWEST QUARTER OF SAID NORTHEAST QUARTER OF SECTION 19 S86°57'29"W, 919.55 FEET TO THE SOUTHWEST CORNER OF SAID NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 19;
