BUSINESS INNOVATION ACT (BIA)

In 2014, the Legislature unanimously passed, and the Governor signed, LB 1114 which was comprised of two main components: 1) extending the sunset date for the Business Innovation Act from 2016 to 2021; and 2) requiring the Nebraska Department of Economic Development (DED) to contract with a Nebraska-based non-profit organization to “provide research, analysis of best practices in other states, and make recommendations on ways to support and increase venture capital in Nebraska.” Invest Nebraska was selected by DED to author the study as required under LB 1114. Invest Nebraska subsequently contracted with Dr. Eric Thompson, Director of the Bureau of Business Research and an Associate Professor of Economics at the University of Nebraska-Lincoln, to conduct a research study on the Nebraska Business Innovation Act.

Dr. Thompson conducted a research study of the four main innovation programs under the Nebraska Business Innovation Act specifically 1) the Pre-seed Prototype grant program, 2) the matching state support for Federal Small Business Innovative Research (SBIR) grants, 3) the Academic Research and Development grant program, and 4) the Seed/Commercialization program. Companies participating in the programs between October 2011 and June 2014 were surveyed.

Dr. Thompson’s economic impact analysis found significant private sector investment for each dollar of state support. Businesses participating in Nebraska Business Innovation Act programs raised \$5.12 in private investment funding for each \$1 dollar of state funding. A significant portion of this private investment was money raised after the required match. These initial investments of equity, loans, grants and other sources of capital helped sustain these businesses throughout their development processes. The goal is for businesses to ultimately be funded by revenue from sales, and some participating businesses already have advanced to the point of earning substantial revenues.

Dr. Thompson’s study found that participating businesses have earned \$2.32 in revenue from sales for each \$1 of state funding. Revenue earned from sales will grow as firms advance further through the development and commercialization process.

Businesses participating in Nebraska Business Innovation Act programs have already had an economic impact on Nebraska. These businesses have added 162 jobs with annual wages totaling \$8.2 million since their initial involvement in Nebraska Business Innovation Act programs. These are direct economic impacts. These businesses also had a significant total economic and tax revenue impact. The total annual economic impact was \$53.45 million. The annual economic impact in terms of direct and indirect employee compensation was \$15.23 million spread over 307 jobs. These results suggest wages per job of \$49,665 including both the direct and multiplier employment. This finding implies that the innovative, growing businesses supported by Nebraska Business Innovation Act programs provide high wage employment. In the 2013-2014 fiscal year, the Business Innovation Act (BIA) provided grant funding or commercialization investment to 44 companies, helping spur entrepreneurship and support the transfer of Nebraska-based technology and innovation statewide. DED provided more than \$5.1 million in funding and leveraged more than \$11.7 million in non-state investment for innovation projects. Recipients continue to report that the BIA funding allowed them to move forward with a project, product, or technology they otherwise would not have been able to advance, sped up commercialization, and led to job creation, increased revenue, and additional investment.

NEBRASKA OPERATIONAL ASSISTANCE ACT

The Nebraska Operational Assistance Act requires DED to develop a program to assist potential high-growth businesses to establish a foundation sufficient for the attraction of private equity.

This assistance includes:

- market analysis
- executive recruitment
- sales and marketing
- financial planning
- business structure
- business plan review
- intellectual property development

The program, provided under the Act, also may include:

- cooperating with other service entities to facilitate the effectiveness of the overall program;
- developing a statewide system to facilitate venture capital investing;
- identifying potential investors and providing those investors with information about investment opportunities in Nebraska;
- developing a clearinghouse and access point for information about venture capital investment opportunities in Nebraska;
- serving as the central organization and establishing a means of delivering appropriate education and training programs for potential investors in business enterprises; and
- helping form intrastate or industry-specific venture capital networks.

Invest Nebraska Corporation, a non-profit 501(c)(3) public-private venture development organization, was selected by DED to develop the program under the Act. The organization advises and invests in early stage businesses across the state. Invest Nebraska is governed by a 12-member volunteer board of directors whose experience includes: university research and commercialization, venture capital,

accounting, investment portfolio management, angel investing, private equity, early-stage entrepreneurial development, patent law, transaction law, and banking. The organization is led by an entrepreneur with significant venture capital experience.

Since 2009, Invest Nebraska has provided financial assistance totaling over \$5.6 million to start-up businesses in Nebraska in the form of low-interest loans and equity ownership. As of December 31, 2014, these businesses received a total of \$12 million of co-invested capital along with the Invest Nebraska financial assistance. These companies also received \$40.2 million in subsequent follow-on capital for the period 2009 through 2014.

During calendar year 2014, Invest Nebraska:

- reviewed 70 business plans;
- engaged 118 entrepreneurs to discuss ideas and/or businesses;
- listened to 80 pitches and provided follow-up feedback; and
- conducted follow-up with 24 companies for possible financial assistance.





Invest Nebraska also engaged 57 individual Nebraska angel investors residing outside of the Omaha/Lincoln area, 65 individual Nebraska angel investors residing in the Omaha/Lincoln area, and 15 institutional investors representing private equity, venture capitalists, and mezzanine financiers. Developing these relationships helps move Nebraska toward establishing a comprehensive network of angel and institutional capital investing in start-ups and businesses.

Invest Nebraska also maintains an online clearinghouse and access point for information about angel investment opportunities in Nebraska. Gust (formerly known as angelsoft) provides the global platform for the sourcing and management of early-stage investments. The platform is endorsed by the

Angel Capital Association, World Business Angels Association, and National Angel Capital Organization.

Potential or interested accredited angel investors contact Invest Nebraska for access to the clearinghouse. The investors are e-invited to be members of a “deal room.” Individuals receive an email from Invest Nebraska granting them access. In the deal room, interested angels can review material provided by the company, information completed by Invest Nebraska, and possible comments about the deal. If the angel requires additional information regarding the company, they can contact Invest Nebraska, or the owner of the company.



CIVIC AND COMMUNITY CENTER FINANCING FUND

In 2014 there were 56 total applicants under the Civic and Community Center Financing Fund (CCCFF) pre-application cycle. Of those, 37 were invited to submit a full application, and 13 municipalities were awarded funds. A total of \$4.88 million was awarded to the cities of Bellevue, Blair, Burwell, Deshler, Hastings, Hickman, Kimball, Lexington, Lyons and Pender for projects related to the construction, renovation and development of civic, cultural and convention centers, respectively. Kearney, Plattsmouth and South Sioux City were awarded funds to conduct planning studies. All FY 2013-2014 appropriated funds were committed or are under contract.

All applications are reviewed competitively based on criteria outlined in Neb. Rev. State Statute §13-2707 and 13-2707.01 and Title 90 NAC Rules and Regulations. A municipality receiving a grant from the Fund must own the civic, cultural, or convention center for which grant assistance is sought. The grant amount can be up to fifty percent of the cost of construction, renovation, or expansion of the center. The maximum grant amount is also determined by the population size of a municipality.

DED plans the timing of award cycles to coincide with anticipated sufficient funds available for award and the construction season. DED plans to hold an

award cycle annually if the fund balance less unpaid funds to committed projects and upcoming fund transfers out is a sufficient amount to do so.

Awarded Projects

The following is a summary of the projects that were awarded. These projects scored higher than those projects not awarded in the areas of retention impact, new resident impact, visitor impact, financial support, project readiness and public support, project planning and project location.

The City of Bellevue was awarded \$1.125 million for the Bellevue Convention Center. The modern event and meeting facility is located in the Twin Creek Village development and will be paired with a quality hotel, a newly-remodeled movie theatre, businesses, medical and professional offices, and multi-family housing.

The City of Blair was awarded \$375,000 for the Blair Library and Technology Center. The proposed Library and Technology Center is located on Highway 75 along the City's walking and biking trail connecting it to other areas of the community. The new facility will provide a wide range of information and technological services and offer valuable meeting space for civic

organizations while supporting cultural engagement and providing resources to local businesses.

The City of Burwell was awarded \$375,000 for the Burwell Area/Calamus Conference Center. The proposed facility will accommodate the growing demand for a meeting and event center by having capacity for approximately 500 people with a serving kitchen. Additionally, a portion of the center will include a Rodeo History exhibit and a visitor information center designed to attract additional visitors to central Nebraska.

The City of Deshler was awarded \$250,000 for the Deshler Public Library. The construction of an approximately 5,678-square-foot library to meet ADA specifications will better serve the community at large as a resource hub with a space and new technologies available for residents and organizations.

The City of Hastings was awarded \$750,000 for the Hastings City Auditorium. The project will renovate and expand the 90-year-old auditorium located near restaurant, retail, and entertainment venues by adding approximately 13,000-square-feet for additional conference, gathering, and break out space. The new space will be developed in the form of a “link facility” attracting mixed use development directly south of the Auditorium.

The City of Hickman was awarded \$375,000 for the Hickman Community Center. Located in downtown Hickman, the new center will provide a space to host both small-and large-scale athletic and civic events while acting as a “safe hub for community bonding.” The Center will combine the services of a Community Center and City Offices and offer additional services, including a “Reading Centre.”

The City of Kearney was awarded \$10,000 for recreation planning. The planning funds will be used to determine possible locations for new softball and baseball facilities and feasibility of land acquisition.

The City of Kimball was awarded \$250,000 for the Kimball Event Center. Enhancements will upgrade restrooms to be ADA compliant and modernize the center to promote further use of the ballroom, meeting space, kitchen, and a publicly-accessible fitness center.

The City of Lexington was awarded \$600,000 to construct the Lexington Fieldhouse, providing additional space to increase community options for recreation. The facility will have an artificial turf playing area to accommodate soccer, lacrosse, flag football, dodgeball, day camps, etc.

The City of Lyons was awarded \$375,000 for the Lyons Community Center. Renovations will expand usable gathering space with less maintenance, heating, and cooling costs. The renovated facility will address existing health safety concerns with the installation of a fire sprinkler system and enhancements to restroom accommodations.

The Village of Pender was awarded \$375,000 to build a Community Center. The 6,600-square-foot facility will host community events, provide space for organizations and businesses to meet potential clients, and showcase the Veterans Memorial Park east of the facility. Additionally, the Center will include a public wellness center and walking track, allowing residents to take advantage of these amenities locally rather than

having to travel to surrounding communities.

The City of Plattsmouth was awarded \$10,000 to plan for a new entertainment plaza. Located on Main Street, safety concerns related to damage from a recent nearby fire has made the outdoor entertainment plaza unusable. Initial planning involves the development of a larger, improved entertainment plaza to host a wider array of outdoor recreation and cultural events.

The City of South Sioux City was awarded \$10,000 to plan the construction of a Recreation Center. The possible site is located off of Interstate 29 and presently surrounded by 15 soccer fields. The City seeks to design a facility to accommodate several indoor sports tournaments and other events, including agricultural, dog, and boat shows.

Non-Select

The following is a summary of the full applications that were not recommended for award and the reason for non-selection. Details about matching funds were provided where available.

The Village of Amherst applied for playground improvements. The application requested \$22,000 in grant funding and provided \$24,811.06 in matching funds. The matching funds were made up of village-budgeted general funds and in-kind contributions. The application was not selected because, compared to the awarded projects, the playground project application did not score as high in the areas of visitor impact (i.e. the likelihood of the project enhancing or creating an attraction that would increase the potential of visitors to the community). Many of the selected projects are new attractions and amenities that are more likely to increase community visits.

The City of Atkinson applied for a community center project. The application requested \$28,502 in grant funding and provided \$34,838 in matching funds. The matching funds were from the city treasury that had already budgeted money for maintenance updates. The application was not selected because, compared to the awarded projects, the project application did not score as high in the area of new resident impact (i.e. the likelihood of the project attracting new residents to the community). Many of

the selected projects are new attractions and amenities that would have a larger impact for new residents.

The City of Bennington applied for the development of the Doug Nelson Youth Complex. The application requested \$117,500 in grant funding and provided \$117,500 in matching funds. The matching funds were from in-kind contributions, fundraising, and other foundations. The application was not selected because, compared to the awarded projects, the application did not score as high in the financial support category (i.e. the amount and availability of matching funds). All of the selected projects have matching funds committed and are immediately available to begin construction.

The City of Central City applied for the Central City Civic Center project. The application requested \$375,000 in grant funding and provided \$429,900 in matching funds. The matching funds were from funds set aside in the City's utility departments. The application was not selected because, compared to the awarded projects, the application did not score as high in the project planning category (i.e. diligence and preparation for the project). Many of the selected

projects had feasibility studies, market analysis, and/or architectural/engineering work completed.

The City of Chadron applied for a Community Lifespan Wellness Center project. The application requested \$375,000 in grant funding and provided \$6,314,000 in matching funds. The matching funds come from municipal bonds (1/2 cent increase in sales tax), foundation/grant funding, a USDA low-interest loan, and funding from Chadron State College designated as a user fee. The application was not selected because, compared to the awarded projects, the application did not score as high in the project readiness category (i.e. the ability to quickly finance and implement the project plan). Many of the selected projects were ready to begin construction immediately.

The City of Columbus applied for a Public Library/Cultural Arts Center project. The application requested \$750,000 in grant funding and provided \$750,000 in matching funds. The matching funds will come from the Public Library Foundation. The application was not selected because, compared to the awarded projects, the library and arts center project application did not score as high in the areas of project readiness and

financial support (i.e. the ability to quickly finance and begin construction). Many of the selected projects have finances immediately available to begin and complete construction.

The Village of Culbertson applied for a Public Library/Civic Center project. The application requested \$150,000 in grant funding and provided \$300,000 in matching funds. The matching funds will come from money raised through public and private donations, capital campaigns, fundraisers, and grants. The application was not selected because, compared to the awarded projects, the library project application did not score as high in the areas of visitor impact (i.e. the likelihood of the project enhancing or creating an attraction that would increase the potential of visitors to the community). Many of the selected projects are new attractions and amenities that are more likely to increase community visits.

The City of Fairfield applied for a Fairfield Elementary School planning project. The application requested \$4,750 in grant funding and provided \$4,750 in matching funds. The matching funds will come from the City budget. The application was not selected because the proposed planning project is not eligible for technical assistance under CCCFF. Statute provides that eligible technical assistance (planning) grants are for engineering and technical studies directly related to eligible projects. The end-use of the building was not identified as an eligible project.

The City of Falls City applied for a Falls City Auditorium project. The application requested \$110,750 in grant funding and provided \$110,750 in matching funds. The matching funds will come from the Capital Project Sinking Fund budgeted from sales tax revenues pledged to the General Fund. The application was not selected because, compared to the awarded projects, the auditorium project application did not score as high in the overall impact (i.e. the benefit to existing residents, new residents, and visitors). Many of the selected projects are new attractions and amenities that would have a larger impact related to these criteria.

The City of Humboldt applied for a Humboldt Auditorium project. The application requested \$375,000 in grant funding and provided \$375,000 in matching funds. The matching funds will come from fundraised money and coordinated efforts between

local, area, statewide, and national levels to secure support. The application was not selected because, compared to the awarded projects, the application did not score as high in the financial support category (i.e. the amount and availability of matching funds). All of the selected projects have matching funds committed and are immediately available to begin and complete construction.

The Village of Oconto applied for a Playground Equipment Improvement project. The application requested \$12,000 in grant funding and provided approximately \$17,000 in matching funds. The matching funds will come from in-kind contributions and the Village's Recreation/Community Development Funds. The project was not selected because, compared to the awarded projects, the application did not score as high in the areas of visitor impact (i.e. the likelihood of the project enhancing or creating an attraction that would increase the potential of visitors to the community). Many of the selected projects are attractions and amenities that are more likely to increase community visits.

The City of Ord applied for a Municipal Swimming Pool project. The application requested \$250,000 in grant funding and provided \$2,252,250 in matching funds from a donation from the Alfred and Irma Burson Trust, excess sales tax funds, private donations, and a Wozab Grant. The application was not selected because, compared to the awarded projects, the application did not score as high in the area of financial support (i.e. the financial commitment available to the project). Many of the selected projects have the financial sources immediately available to begin and finish construction.

The City of Plainview applied for a Municipal Public Library project. The application requested \$375,000 in grant funding and provided \$819,000 in matching funds. The matching funds will come from sales tax revenue, possible bond issue, and the nonprofit Plainview Foundation. The application was not selected because, compared to the awarded projects, the application did not score as high in the financial support category (i.e. the amount and availability of matching funds). All of the selected projects have matching funds committed and immediately available to begin and complete construction.

The Village of Potter applied for a Community Center planning project. The application requested \$10,000 in grant funding and provided \$10,000 in matching funds. The matching funds will come from the Village funds. The application was not selected because, compared to the awarded planning projects, the application did not score as high in the area of project planning, specifically the project was not identified as a need or priority within a participatory planning process like a comprehensive plan, strategic plan, or community needs assessment.

The City of Randolph applied for a City Auditorium project. The application requested \$75,000 in grant funding and provided \$75,000 in matching funds. The matching funds will come from property taxes, auditorium rentals, and proprietary funds. The application was not selected because, compared to the awarded projects, the application did not score as high in the new resident impact category (i.e. the ability for the completed project to attract new full-time residents to the community). Many of the selected projects are new attractions and amenities that greatly enhance the quality of life of the community.

The City of Ravenna applied for a Public Library planning project. The application requested \$10,000 in grant funding and provided \$10,000 in matching funds. The matching funds will come from fundraising efforts, community members, and local businesses. The application was not selected because, compared to the awarded planning projects, the application did not score as high in the area of project planning, specifically the project was not identified as a need or priority within a participatory planning process like a comprehensive plan, strategic plan, or community needs assessment.

The City of Schuyler applied for the Top Notch Building planning project. The application requested \$7,500 in grant funding and provided \$7,500 in matching funds. The matching funds will come from the local LB840 fund. The application was not selected because the proposed planning project is not eligible for CCCFF technical assistance. Statute provides that eligible technical assistance (planning) grants are for engineering and technical studies directly related

to eligible projects. The end-use of the Top Notch building, was not identified as an eligible project.

The City of St. Paul applied for a St. Paul Area Civic Center project. The application requested \$375,000 in grant funding and provided \$875,000 in matching funds. The matching funds come from private sources. The application was not selected because, compared to the awarded projects, the Community Center project application did not score as high in the area of project planning (i.e. the diligence and preparation in advance of the project). Many of the selected projects have completed feasibility and market studies as well as architectural and engineering work.

The Village of Walthill applied for the Walthill Legion Hall project. The application requested \$12,100 in grant funding and provided \$15,600 in matching funds. The matching funds come from in-kind and other local sources. The application was not selected because, compared to the awarded projects, the application did not score as high in the new resident and visitor impact categories (i.e. the ability of projects to attract new permanent residents and visitors to the community). Most of the selected projects are new attractions and amenities that significantly impact the quality of life in the community.

Non-Select Preliminary Applications

The following is a summary of the preliminary applications that were not invited to submit a full application and the reason for non-selection. Details about matching funds were provided where available.

The Village of Adams applied for a Community Building project. The preliminary application requested \$250,000 in funding. It was not selected to complete a full application because the project application did not represent that the project had the prior planning or financial readiness of other evaluated civic center applications. Statute directs that projects

with a high-level of planning and financial match in place are to be prioritized.

The City of Alma applied for a Swimming Pool project. The preliminary application requested \$375,000 in funding. It was not selected to complete a full application because the project was not as financially ready as other evaluated swimming pool projects. With the indication that maintenance expenses were a significant issue with the existing pool, the committee questioned the sustainability of the investment and the project's long-term effects on the selection criteria.

The City of Bayard applied for redevelopment of Main Street buildings. The preliminary application

requested \$10,000 in funding. It was not selected to complete a full application because plans for the redevelopment had not been finalized. Statute directs that projects with a high level of planning are prioritized for selection.

The City of Bridgeport applied for a Prairie Winds Community Center project. The preliminary application requested \$55,000 in funding. It was not selected to complete a full application because construction of the tennis courts did not significantly address the selection criteria in relation to other evaluated larger-scale athletic and recreation center applications.

The City of Burwell applied for a Swimming Pool project. The preliminary application requested \$9,650 in funding. It was not selected to complete a full application because the community of Burwell is being invited to submit a full application for a conference center project. The swimming pool project was deemed to not be as competitive in addressing the selection criteria.

The City of Fairbury applied for a Pool Feasibility Study. The preliminary application requested \$10,000 in funding. It was not selected to complete a full application because the pool feasibility study did not address the selection criteria as well as other evaluated planning project applications. There is a limit on the appropriation to be utilized for planning projects. Demand for planning projects exceeded the available funding. The language of the preparatory scope as well as the needed improvements to the existing pool make a new facility mandatory and negates the need for a comparison study.

The City of Grand Island applied for a Veterans Field Complex project. The preliminary application requested \$1,125,000 in funding. The City of Grand Island would supply the matching funds. It was not selected to complete a full application because state lease of the land is not eligible under the municipal ownership requirement of the program statute. The City of Grand Island also applied for an Island Oasis Waterpark project. The preliminary application requested \$1,125,000 in grant funding. The City of Grand Island committed to provide necessary

matching funds. It was not selected to complete a full application because the project was not financially ready as other evaluated water park projects. The project is not sustainable due to the maintenance expenses which are a significant issue with the existing complex.

In addition to its successful application for the City Auditorium, the City of Hastings also submitted an application to renovate the existing Public Library. The preliminary application requested \$ 500,000 in funding and provided \$3,800,000 in matching funds. The matching funds were from city sales tax revenue and private donations. It was not selected to complete a full application because, based on statute, only one project can be funded per community in a five-year period. The City Auditorium project scored higher using evaluation criteria.

The City of Holdrege applied for a Splash Pad project. The preliminary application requested \$97,000 in funding and provided \$101,000 in matching funds. The City of Holdrege plans to provide matching funds secured from the Park Department Capital Outlay Account. It was not selected because splash pad projects do not significantly address the selection criteria in relation to other evaluated larger-scale aquatic center applications.

The City of La Vista applied for a Sports Complex project. The preliminary application requested \$281,000 in funding. It was not selected to complete a full application because the facility upgrades were not as competitive at addressing the selection criteria as other evaluated new construction or major renovation projects for athletic complexes.

The Village of Loomis applied for a Splash Pad project. The preliminary application requested \$80,000 in funding and provided \$80,000 in matching funds. The matching funds were from Village resources. It was not selected because splash pad projects do not significantly address the selection criteria in relation to other evaluated larger-scale aquatic center applications.

The City of Oshkosh applied for a Swimming Pool project. The preliminary application requested \$375,000 in funding and provided \$1,800,000 in

matching funds. The matching funds were from private grants, bonds, and fundraising contributions. It was not selected to complete a full application because the project was not as financially ready as other evaluated swimming pool projects and because the project was not as financially ready as other evaluated water park projects. The project is not sustainable due to the maintenance expenses which are a significant issue with the existing complex.

The Village of Panama applied for a Community Center project. The preliminary application requested \$50,000 in funding and provided \$50,000 in matching funds. It was not selected to complete a full application because the project was not as ready to begin construction as other evaluated project applications.

The City of Scottsbluff applied for a Community Center project. The preliminary application requested \$600,000 in funding. It was not selected to complete a full application because the long-term lease agreement of the project was not eligible under the municipal ownership requirement of the statute.

The Village of Sumner applied for a Splash Pad project. The preliminary application requested \$30,000 in funding and provided \$11,000 in matching funds. The matching funds were from fundraisers, letters of donation, and raffles. The preliminary application was not selected to complete a full application because splash pad projects do not significantly address the selection criteria in relation to other evaluated larger-scale aquatic center applications.

The City of Sutton applied for an Activities Center project. The preliminary application requested \$375,000 in funding and provided \$1,000,000 in matching funds. The matching funds were from bonds backed by a 1% local sales tax. The preliminary application was not selected to complete a full application because fund priorities for projects are to be used for projects that demonstrate a high level of financial readiness. The project application demonstrated a funding gap; therefore it was not as financially ready to begin construction as other evaluated project applications.

The City of Syracuse applied for a Swimming Pool project. The preliminary application requested \$200,000 in funding. It was not selected to complete a full application because fund priorities for swimming pool projects were for new construction or major renovation projects. The accessibility improvements for the Syracuse Swimming Pool would not significantly address the scoring criteria in comparison to other evaluated new construction or major renovation projects on swimming pools.

The Village of Taylor applied for a Convention Center project. The preliminary application requested \$250,000 in funding. It was not selected to complete a full application because projects involving demolition were not identified as a program priority. There are also similar project applications in the region that scored higher in the review process.

The City of Wisner applied for an Auditorium project. The preliminary application requested \$250,000 in funding. It was not selected to complete a full application because insufficient information was provided. It could not be determined that the project was eligible as the pre-application did not identify the scope of the project or address the evaluation criteria set forth in statute.

CUSTOMIZED JOB TRAINING

The Customized Job Training program provides flexible and discretionary grant funding to help ensure that the State's workforce is prepared in advances in rapidly changing technologies and industries. The Job Training Program resulted in 60 job training projects involving 3,016 employees for a total planned cost of \$7,667,647. Of these projects, 15 were newly-awarded (1,189 employees with a total cost

of \$2,923,500). Total Job Training expenditures were \$4,290,531.60.

Of the 60 active projects, 24 (40%) were for businesses located in counties outside the Lincoln and Omaha Metropolitan Statistical Area (MSA). Sixteen projects were in the Lincoln MSA and 20 were in the Omaha MSA.

InternNE

The InternNE program connects college students and employers from across the state, providing a unique opportunity for them to co-invest in the future. Interns gain valuable business experience that will help them in future careers, while successful internships help businesses develop tomorrow's leaders. InternNE program had a total of 455 projects during 2014. Of those, 150 were closed between January 1 and December 31, 2014, leaving 305 active projects at the

end of 2014. Altogether 1,236 internship positions were approved and \$5.325 million granted to the participating companies. Of the awarded positions, 817 were filled during the 2014 calendar year. The InternNE program disbursed \$2,214,689, of which 43% was reimbursed to the 150 companies with contracts that closed during 2014. Of the 455 projects in 2014, 290 were for businesses located within Lancaster, Douglas and Sarpy counties.

SITE AND BUILDING DEVELOPMENT FUND

The purpose of the Site and Building Development Act, as stated in Neb. Rev. Stat. §81-12,145 is to assist in the provision of industrial-ready sites and buildings in all areas of the state to create “conditions favorable to meeting the industrial readiness of the state.” DED is required through the Site and Building Development Act (Neb. Rev. Stat. §81-12,149) to develop a Qualified Action Plan by January 1st of each even numbered calendar year, and the plan is posted on the Department’s website at <http://www.neded.org/files/businessdevelopment/talentinnovation/QualifiedActionPlanSBDFJan12014Dec312015.pdf>

The Qualified Action Plan sets forth the activities eligible for assistance under the Site and Building

Development Act. These activities have been selected by the Department to further priorities which are appropriate to local conditions and the state’s economy. Approval continued for Site and Building Development Fund (SBDF) projects for the 2014 calendar year. Funding was focused on business recruitment and expansion projects that located or expanded in Nebraska. There were no applications received for first priority projects. Due to limited funds, DED did not solicit applications for speculative site or building projects.

AFFORDABLE HOUSING TRUST FUND

The Nebraska Affordable Housing Trust Fund (NAHTF) enhances economic development in the State and provides safe, affordable housing for Nebraska’s citizens. Funding is received from the revenue generated through the State’s Documentary Stamp Tax. For the 2014 calendar year, it awarded \$5,521,470, matched by \$3,359,384 from the grantees; created 177 housing units; and generated employment in the amount of 136.7 positions.

The employment generated data is based on an employment multiplier from IMPLAN, an input/output model used to estimate the impact of economic activity. In this example, construction of housing is estimated to require one construction job for every \$304,850 in construction costs with an estimated employment multiplier of 1.82. In other words, for every job associated with residential construction, 0.82 additional jobs are created in the economy. These jobs may be at businesses that directly support the activity, including lumberyards, home supply stores, furniture stores, or at businesses that support the households of construction workers, such as grocery and retail stores.

The median monthly ownership cost for homeowners with mortgages is \$1,278, and the median monthly ownership cost for homeowners without mortgages is \$458. The median monthly rental cost is \$706.

The total amount of money deposited into the AHTF from January 1-December 31, 2014 was \$8,676,776.33.

The vacancy rate for NAHTF in 2014 is anticipated to be 95 percent. Homeowner vacancy rates and rental vacancy rates for 2010-2013 are as follows:
