Dear Governor Ricketts, Members of the Nebraska Legislature and Fellow Nebraskans:

It is my honor and privilege to present to you the Nebraska Department of Economic Development's 2015 Calendar Year Annual Report.

The Legislature requires annual reports on the following programs:

- The Business Innovation Act, which offers: Prototype grants for product development; the Academic R&D grant program for companies and higher learning institutions collaborating on conducting applied research and development; the Commercialization investment program that helps businesses develop and commercialize new technologies; and SBIR matching grants for businesses that are applying or have already received Phase I/II SBIR/STTR grants from a federal agency.
- The Nebraska Operational Assistance Act helps high-growth businesses with services such as market analysis, executive recruitment, sales and marketing, financial planning, business structure, business plan review, and intellectual property development in order to gain a foothold to attract private equity.
- The Civic and Convention Center Financing Fund is used to construct new civic and recreation centers, or renovate or expand existing civic, community and recreation centers, including converting, rehabilitating or reusing historic buildings. The fund also may be applied to preliminary planning related to the development or rehabilitation of eligible projects.
- Customized Job Training provides employee training assistance to businesses that maintain, expand and diversify the state's economic base and, in the process, create or retain quality jobs for Nebraska residents.
- InternNE connects college students and employers, giving students valuable work experience in potential future careers and helping businesses develop future employees and leaders.
- The Site and Building Development Fund helps provide industrial-ready sites and buildings statewide in an effort to create conditions favorable for industrial expansion and recruitment.
- The Nebraska Affordable Housing Trust Fund helps facilitate the development of safe, affordable housing for Nebraska's citizens.

Our goal continues to be achieving quality measurable goals which not only help Nebraska's economy grow and prosper, but also helps our communities meet their most critical needs.



BUSINESS INNOVATION ACT (BIA)

The 2011 Business Innovation Act (BIA) authorized a suite of grant and investment programs focused on assisting businesses with developing and commercializing new technologies in Nebraska. The main programs include the Prototype grant (for product development), the Commercialization investment program, the Academic R&D grant program for companies conducting applied research and development in conjunction with a Nebraska institute of higher education, and the SBIR matching grant for businesses that are applying for or have received a Phase I/II SBIR/STTR grant from a federal agency. Through these programs, the Business Innovation Act assists high-growth, high-technology companies, small businesses, and microenterprises that create wealth and quality jobs.

Under the BIA, DED provided \$4.8 million in funding for innovation projects during the 2014-2015 fiscal year. For many of the companies that have applied for and received funding for innovation projects, location plays a critical role. Whether it's taking advantage of the proximity to universities, talent, and investors or having more access to markets and industry networks, high tech/high growth companies tend to cluster in metropolitan areas. Thus, a majority of companies that have utilized the innovation funding are based in Lincoln and Omaha. However, working with micro-lending organizations, such as the Center for Rural Affairs Rural Enterprise Assistance Project, many small businesses were able to utilize BIA Microenterprise Assistance Program funding or technical assistance. Twenty-two new microloans totaling \$752 thousand were made in 2014 and 42 microloans totaling \$1.198 million were made in 2015. In addition, 816 clients were provided technical assistance in 2014 and 889 clients received technical assistance in 2015. Many BIA funding recipients have reported that the BIA funding allowed them to move forward with a project, product, or technology they otherwise would not have been able to advance, sped up commercialization, and led to job creation, increased revenue, and additional investment.



Through these programs, the Business Innovation Act assists high-growth, high technology companies, small businesses, and microenterprises that create wealth and quality jobs.

NEBRASKA OPERATIONAL ASSISTANCE ACT

The Nebraska Operational Assistance Act requires DED to develop a program to assist potential high-growth businesses to establish a foundation sufficient for the attraction of private equity. This assistance includes:

- market analysis
- executive recruitment
- sales and marketing
- financial planning
- business structure
- business plan review
- intellectual property development

The program, provided under the Act, also may include:

- cooperating with other service entities to facilitate the effectiveness of the overall program;
- developing a state-wide system to facilitate venture capital investing;
- identifying potential investors and providing those investors with information about investment opportunities in Nebraska;
- developing a clearinghouse and access point for information about venture capital investment opportunities in Nebraska;
- serving as the central organization and establishing a means of delivering appropriate education and training programs for potential investors in business enterprises; and
- helping form intrastate or industry-specific venture capital networks.

Invest Nebraska Corporation, a non-profit 501(c)(3) public-private venture development organization, was selected by DED to develop the program under the Act. The organization advises and invests in early stage businesses across the state. Invest Nebraska is governed by an eight-member volunteer board of directors whose experience includes: university research and commercialization, venture capital, accounting, investment portfolio management, angel investing, private equity, early-stage entrepreneurial development, patent law, transaction law, and banking. The organization is led by an entrepreneur with significant venture capital experience.

Since 2009, Invest Nebraska has provided financial assistance totaling over \$9.67 million to start-up businesses in Nebraska in the form of low-interest loans, convertible debt, and equity.


Since 2009, Invest Nebraska has provided financial assistance totaling over \$9.67 million to start-up businesses in Nebraska in the form of low-interest loans, convertible debt, and equity. As of 12/31/15, these businesses received a total of \$25.67 million of co-invested capital along with the Invest Nebraska financial assistance. These companies also received \$37.7 million in subsequent follow-on capital for the period 2009 through 2015.

During calendar year 2015, Invest Nebraska:

- reviewed 43 business plans
- engaged 96 entrepreneurs to discuss ideas and/or businesses
- listened to 64 pitches and provided follow-up feedback
- conducted follow-up with 27 companies for possible financial assistance

Invest Nebraska also engaged 57 individual Nebraska angel investors residing outside of the Omaha/Lincoln area, 65 individual Nebraska angel investors residing in the Omaha/Lincoln area and 15 institutional investors representing private equity, venture capitalists, and mezzanine financiers. Developing these relationships helps move Nebraska toward developing a comprehensive network of angel and institutional capital investing in start-ups and businesses.

Invest Nebraska also maintains an online clearinghouse and access point for information

about angel investment opportunities in Nebraska. Gust (formerly known as Angelsoft) provides the global platform for the sourcing and management of early-stage investments. The platform is endorsed by the Angel Capital Association, the World Business Angels Association, and the National Angel Capital Organization.

Potential or interested accredited angel investors contact Invest Nebraska for access to the clearinghouse. The investors are e-invited to be members of a "deal room." Individuals receive an email from Invest Nebraska granting them access. In the deal room, interested angels can review material provided by the company, information completed by Invest Nebraska, and possible comments about the deal. If the angel requires additional information regarding the company, they then can contact Invest Nebraska, or the owner of the company.

CIVIC AND CONVENTION CENTER FINANCING FUND

Because civic centers, community centers and recreation centers serve to enrich the lives of citizens, intellectually, culturally, socially, spiritually and physically, the State Legislature created the Civic and Community Center Financing Fund Act with the purpose of supporting their development to foster maintenance and growth of communities throughout Nebraska.

The fund can be used to construct new civic and recreation centers, or renovate or expand existing civic, community and recreation centers, including converting, rehabilitating or reusing historic buildings. The fund also may be applied to preliminary planning related to the development or rehabilitation of eligible projects.

In 2015 there were 34 applicants under the Civic and Community Center Financing Fund (CCCF) pre-application cycle, and 30 were invited to submit a full application. One community rescinded its application due to a delay with the project. An appropriation of \$2.065 million was issued and available as state aid. A total of \$2,029,420 was awarded to municipalities—\$1,974,220 for nine capital construction projects and \$55,200 for six planning projects allowed under the Act.

All full applications are reviewed competitively based on criteria outlined in Neb. Rev. State Statute §13-2707 and 13-2707.01 and Title 90 NAC Rules and Regulations. With the exception of project location, ownership, and operation, each review criterion is awarded a score of up to 10 points (60 point maximum). Applications are scored by each committee member and after discussion, assigned a combined aggregate score and ranked from highest to lowest.

Project funding came from the 2015 fund appropriation, of which \$35,480 has yet to be awarded. Projects were awarded based on a combined score; the highest scoring applications received funding until the amount of requested funds exceeded available balance. The next three highest scoring applications had requested \$375,000.

A municipality receiving a grant from the Fund must own the civic, cultural, or convention center for which grant assistance is sought. The grant amount can be up to fifty percent of the cost of construction, renovation, or expansion of the center. The maximum available grant amount is determined by the population size of a municipality and the balance of the fund.

The Department plans the timing of award cycles to coincide with anticipated sufficient funds available for award and the construction season. The Department plans to hold an award cycle annually if the fund balance less unpaid funds to committed projects and upcoming fund transfers out is a sufficient enough amount to do so.

Awarded Projects

All awarded and approved projects were based on receiving higher scores when compared to non-selected applicants, under the selection criteria as described in Neb. Rev. Statute 13-2707 and detailed in Title 90 Rules

and Regulations and Application Guidelines. These awards left \$35,480 remaining in the fund. Below is summary information provided in each application:

The City of Atkinson was awarded \$35,170 to complete updates to the Atkinson Community Center, including audio and visual equipment, energy efficient lighting and paint. Originally constructed in 1994, the facility was identified as a "true staple" in the community's comprehensive plan, serving as an event space and attracting as many as 400-500 people from outside the community to multiple annual events. Matching funds are being provided by the city and via fundraising efforts. The application scored well in the areas of readiness and local public support and project planning.

The City of Blue Hill was awarded \$10,000 for a planning study to develop a pool and recreation master plan. The existing pool located along the highway is not ADA compliant and has safety concerns related to walkability. The plan will address proposed modifications to the surrounding area, creating a cohesive recreational space along with determining an appropriate location for a new pool to be constructed on the site of or near the existing

municipal pool. Matching funds are being provided by the City (general and park accounts). The application scored well in all areas of review, in particular project planning, financial support, readiness and local public support.

The City of Chadron received \$375,000 for the upgrade of an existing pool as part of development of the Chadron Area Aquatic and Wellness Facility. The project is a result of several surveys and assessments, and is to be developed in partnership with the local hospital, college

and public school system. The completed project will enclose the existing pool and feature other amenities, including zero-depth entry, a water slide, walking track, therapy pool and meeting areas. The project was denied in 2014 based on project readiness. Construction was scheduled to begin in August 2015 and slated for completion in January 2017. Matching funds are being provided by the Kiewit Foundation, Dawes County Travel Board, and fundraising including use of the CDAA program and a half-cent sales tax increase. The application scored highly in the areas of project planning, financial support, project readiness and local public support.

The Village of Cody was awarded \$10,000 for a planning study to develop a recreation center. No such facility is currently located within any surrounding communities and residents must travel more than 40 miles to access a health club. The recreation center would also function as a community gathering place and center for youth and adult activities. Matching funds are being provided by Village funds, in-kind contributions, Cowboy GRIT, and the village is seeking additional grant funding. The application scored highly in the area of project readiness and local public support.

The City of Crete was awarded \$10,000 to complete a community and convention center feasibility study. Currently the Senior Center serves as a place of assembly, however it can only accommodate 50-75 persons. The only other local option, the Saline County Center, is unsuitable for more formal events as it has unfinished walls. The facility will be located within a targeted redevelopment corridor and involve repurposing existing structures. Matching funds are being provided by city funds. The application scored well in the areas of retention impact, readiness and local public support.

The City of David City was awarded \$60,000 to upgrade and remodel the historic David City Municipal Auditorium. A WPA Project built in 1941-1943, the auditorium is the only facility in Butler County large enough to accommodate community, cultural and social events. The project includes the installation of ADA accessible parking, painting and lighting improvements, and remodeling the facility's restrooms, including upgrades to fixtures, flooring, paint and ADA accessibility. Matching funds are being provided by the City and other local sources (93% cash-general fund, 1.5% sales tax, and in-kind city staff). The application scored well in the areas of visitor impact and financial support.

The City of Humboldt was awarded \$375,000 for the historic Humboldt Auditorium. The project includes multiple phases of restoration and renovation of the historic building to serve modern needs. Originally constructed in 1941 as a part of the WPA Program, the building closed due to ADA accessibility concerns. The first phase of the project involves the addition of fire exits, new restrooms and ADA accessibility improvements including the installation of an elevator. The restoration is part of a larger effort to revitalize the downtown square where the historic concrete auditorium stands. Matching funds are being provided by public monies, local private and civic contributions and additional grant and funding opportunities are being sought. The application scored well in the areas of visitor impact, readiness, local public support and project planning.

The Village of Panama was awarded \$74,050 for construction of the Panama Community Center. Located in downtown Panama, the new 2,560 square-foot building is the first of its kind in the community and located adjacent to the new library, the post office and village offices. Significant work was completed by local volunteers, and the facility includes a warming kitchen and ADA-compliant restrooms. Some of the fixtures were repurposed from Lincoln's Pershing Auditorium, including restroom and kitchen items. A number of local social and special interest clubs will call the new community center home. Matching funds are being provided by community foundation fundraising, in-kind labor, and a loan financed through a local bank. The application scored well in the areas of readiness, local public support and financial support.

The Village of Pilger was awarded \$250,000 to develop a new multi-purpose community center to replace many facilities lost during a 2014 tornado. The new facility will include a large event space, computer and media room, kitchen, conference room, senior center, exercise facility, and ADA compliant restrooms that will double as safe rooms. In addition, Pilger plans to offer educational programming for area youth and adults. The project is being developed through multiple public-private partnerships. Matching funds are being provided by village funds and private company donations, including major donors via the Community Action Council. The application scored well in the areas of retention impact and project planning.

The City of Plainview was awarded \$375,000 for the Plainview Public Library. The new 7,000 square foot library will replace the 1916 Carnegie library that is not ADA accessible and does not provide adequate space for programming and technology. The new library will also function as a civic center with a dividable multipurpose room. Other features include a dedicated children's area, kitchen, reading room, gallery and coffee bar, and computer lab. Project budget includes federal and multiple state programs, as well as local contributions, local tax bond and private foundation grants. The application scored well in the areas of readiness, local public support and project planning.

The Village of Potter was awarded \$10,000 to complete a planning study for a community recreation center, including reuse and/or sale of existing buildings currently functioning as the senior center, youth center and the Legion Hall to provide an economical/practical multi-purpose facility. The study will also consider the extent of multi-functionality of the community recreation center. Matching funds are being provided by the village. The application scored well in the areas of readiness, local public support and financial support.

The City of Ravenna was awarded \$5,200 to complete a feasibility and conceptual study for the Ravenna Public Library. The study will analyze and determine options for renovating the existing Carnegie library built in 1918, or constructing a new facility at a nearby vacant lot. Plans will also address potential repurpose and reuse of the historic building as it is considered an important feature of the community. Matching funds are being provided by the city. The application scored well in the areas of project planning and financial support.

The City of St. Paul was awarded \$375,000 for phase one construction of the St. Paul Area Community and Recreation Center. The new 13,596 square foot community center will be located at the east edge of downtown and include a large room that can be converted to two separate multipurpose rooms, a conference room, two offices, a full kitchen, mechanical room, covered canopy, vestibule, lobby, ADA compliant restrooms and a storage area. The project is forecasted as a catalyst for further development of the downtown area. Phase two involves construction of the \$1.8 million recreation center for which the City has purchased hardwood flooring from the Pershing Auditorium auction. Matching funds for phase one are being provided by private donations,

Howard County Community Foundation, St. Paul Development Corp and a USDA-RD loan. The application scored well in the areas of financial support, readiness, local public support and new resident impact.

The City of Wakefield was awarded \$10,000 for a community center feasibility study. As the population center of the county and home to a number of active civic groups, currently no such facility exists within the city. In addition, the facility is expected to complement the community's outdoor annual events, such as the Hot Air Balloon Festival and a number of baseball tournaments. Matching funds are being provided by the city. The application scored well in the areas of project planning and financial support.

The City of Walthill was awarded \$55,000 to convert its old fire station into a public library, relocating the existing facility away from a local tavern and across from the park. The new location will allow for expanded hours and additional space for popular programming, as

well as a separate meeting space and kitchen area. The renovated facility will more than double space of the existing library. Matching funds are being provided by private businesses and foundation donations, volunteer project labor and a CDBG Public Works grant. The application scored well in the areas of financial support and project planning.

Non-Select

The following is a summary of the full applications that were not recommended for award and the reason for non-selection. Details about matching funds were provided where available. In general, many of the selected projects have attractions and amenities that the review committee determined are more likely to have a larger impact in the review criteria.

The City of Bennington requested \$375,000 for expansion and renovations of the public library. Matching funds were identified as coming from local community foundations and contributors in the amount of \$699,476.

The activities to be funded were the first two phases of a three phase project, generally involving renovation of library space, exterior renovations and site improvements. The application was not selected because, compared to the awarded projects, the project application did not score as high in the areas of retention impact, new resident impact and visitor impact.

The City of Broken Bow requested \$375,000 in grant funding to expand and renovate the public library and provided \$659,544 in matching funds. The matching funds were from the city and a library foundation campaign. The project scored well in the area of readiness, local public support and project planning. However, the application was not selected because, compared to the awarded projects, the library project application did not score as high in the areas of retention impact, new resident impact and financial support.

The City of Genoa applied for the development of the Genoa Indoor Sports and Recreation Center. The application requested \$167,500 in grant funding and provided \$221,836 in matching funds. The matching funds were from cash donations and in-kind contributions of labor and/or materials. Genoa scored well in the area of financial support, readiness and local public support. However, compared to the awarded projects, the sports and recreation center project application did not score as high in the areas of retention impact, new resident impact and visitor impact.

The City of Grand Island applied for the Island Oasis Water Park project. The application requested \$800,000 in grant funding and provided \$800,000 in matching funds. The matching funds were from the city's 2015-2016 operating budget. Grand Island scored well in the areas of visitor impact and financial support. However, compared to the awarded projects, the Island Oasis Water Park project application did not score as high in the areas of retention impact, new resident impact, readiness and local public support.

The City of Kearney applied for the development of a ten field softball/baseball complex. The application requested \$750,000

in grant funding and provided \$6.75 million in matching funds. The matching funds were from a city bond and funds from the restaurant and drinking place occupation tax. Kearney scored well in the areas of readiness, local public support and project planning. However, compared to the awarded projects, the softball/baseball complex project application did not score as high in the areas of retention impact and new resident impact.

The Village of Milligan applied for the construction of a new public library. The application requested \$70,000 in grant funding and identified \$134,182 matching in-kind funds and cash donations. Compared to the awarded projects, the application did not score as high in the areas of new resident impact, visitor impact, readiness, local public support and project planning. A primary reason the application was not selected was because it was not as clear about project details compared with other reviewed applications. The submitted project budget also was incomplete. Furthermore, many of the selected projects performed and described either technical and feasibility studies and/or informal planning meetings involving public participation and involvement in the planning process. Such activities have shown to provide a positive impact on overall project readiness and public support. Milligan scored well in retention impact.

The City of Norfolk applied to expand and renovate its existing public library. The application requested \$750,000 in grant funding and provided \$7.66 million in matching funds from money raised through the library foundation and an additional sales tax (collection began April 2015). Norfolk scored well in the area of project planning. However, compared to awarded projects, the library project application did not score as high in the areas of retention impact, visitor impact, readiness and local public support. Many selected projects were set to begin construction in 2015-2016. Hence due to construction beginning in 2017, the community was encouraged to apply closer to the start of construction.

The City of Ord applied for construction of the new Ord Aquatic Center project. The application requested \$375,000 in grant funding and provided \$2,127,250 in matching funds from private foundations, donations and the city's general fund. Ord scored well in the areas of readiness and local public support. However, compared to the awarded projects, the aquatic center project application did not score as high in the areas of retention impact, new resident impact and visitor impact.

The City of Papillion applied for the renovation and expansion of the Sump Memorial Library. The application requested \$326,554 in grant funding and provided \$326,554 in matching funds from the city's 2015-2016 fiscal budget. Papillion scored well in the area of financial support. However, compared to the awarded projects, the library project application did not score as high in the areas of retention impact, new resident impact, readiness, local public support and project planning. Many of the selected projects have completed feasibility studies and/or architectural/engineering work and have attractions and amenities that the review committee determined are more likely to have a larger impact in the review criteria.

The City of Randolph applied to expand its golf course clubhouse into a community center. The application requested \$60,000 in grant funding and provided \$90,000 in matching funds from community labor and vendor cash rebates. Randolph scored well in the areas of readiness and local public support. However, compared to the awarded projects, the community golf course project application did not score as high in the areas of retention impact, new resident impact, visitor impact and project planning. Many of the selected projects had completed feasibility studies and/or architectural/engineering work and have attractions and amenities that the review committee determined are more likely to have a larger impact in the review criteria.

The City of Scottsbluff applied for a downtown plaza project involving the redevelopment of the farmers market site as a community gathering area. The application requested \$600,000 in grant funding and

provided \$1 million in matching funds from in-kind contributions, private foundations and the city. Scottsbluff scored well in the area of project planning. However, compared to the awarded projects, the downtown plaza project application did not score as high in the areas of retention impact, new resident impact and financial support. Many of the selected projects have finances immediately available to begin and complete construction and have attractions and amenities that the review committee determined are more likely to have a larger impact in the review criteria.

The City of Scribner applied for the Furstenau Civic Center/Library Building project. The application requested \$375,000 in grant funding and provided \$631,327 in matching funds from the city and Furstenau Trust Fund. Scribner scored well in the areas of readiness and local public support. However, compared to the awarded projects, the Furstenau Civic Center/Library Building project application did not score as high in the areas of retention impact, new resident impact, visitor impact and financial support. Many of the selected projects have finances immediately available to begin and complete construction and have attractions and amenities that the review committee determined are more likely to have a larger impact in the review criteria.

The City of Seward applied for the Civic Center North Building project, involving the development of a civic center complex. The application requested \$167,500 in grant funding and provided \$167,500 in matching funds from fundraising, the city (including LB840) and the Langworthy Trust. The proposed project activities outlined in the application included acquisition of the building to be used as a civic center, however, a requirement of the program is that the municipality owns the facility for which the grant is being applied. It was previously discussed with Mr. Charles Lieske that these activities were outside the purposes of the program as statutorily identified thus the project as presented was ineligible. Seward scored well in the area of visitor impact and financial support for the overall project.

The City of Wisner applied for the Wisner Auditorium project, involving improvements/

upgrades to the existing facility. The application requested \$375,000 in grant funding and provided \$688,109 in matching funds from local donations and fundraising (including use of the CDAA program), and private foundations. Wisner scored well in the areas of readiness and local public support. However, compared to the awarded projects, the city auditorium project application did not score as high in the areas of retention impact, new resident impact and visitor impact.

Non-Select Preliminary Applications

The following is a summary of the preliminary applications that were not invited to submit a full application and the reason for non-selection. Details about matching funds were provided where available. Four communities were issued notice of non-selection letters. Seward was invited to submit an application with the understanding that the acquisition of its building must be in place and that funds were not to be used for such expenses.

The Village of Oxford's preliminary application for a park and recreation center planning project requested \$10,000 in funding

with \$5,000 in matching funds from the Village's general and park funds and in-kind support. It was not selected to complete a full application because the review committee determined the project was too broad in scope and needed a more defined focus to develop an effective recreation master plan. Furthermore, the application narrative did not address the selection criteria as well as other evaluated planning project applications and the program requires that CCCFF grant assistance be matched at least equally from local sources.

The City of Bridgeport applied for the Prairie Winds Community Center project. The preliminary application requested \$68,750 in funding and included no information regarding matching funds. The Prairie Winds Community Center project involves the installation of swimming lanes in place of an underused racquetball area. The project was not selected to complete a full application because the purpose of the fund is to provide assistance grants for new construction, or renovation or expansion of existing facilities. This proposed project involved the purchase and installation of specialized equipment. In addition, the review committee was unable to determine

community support for the project based on the provided narrative. Compared to other applicants, the project did not provide adequate information related to the criteria set forth in the application guidelines.

The City of Madison's preliminary application for the Madison City Auditorium Project requested \$300,000 to expand the existing facility. No information regarding source or amount of matching funds was included. The project was not selected to complete a full application because the review committee was unable to determine how the expansion of the existing auditorium as described in the application would significantly address the scoring criteria. Furthermore, in comparison to other applicants, the project did not provide adequate information related to the criteria set forth in the application guidelines; specifically, the review committee was unable to identify public support, or demonstrated planning efforts for such project.

The City of Seward applied for grant assistance for the Civic Center North Building Project. The preliminary application requested up to \$250,000 in funding and identified matching funds from the Langworthy Trust. A significant portion of the funds requested were earmarked for property acquisition. The project was not selected to complete a full application because the proposed project activities outlined in the preliminary application included activities outside the purpose of the program as identified in state statute thus making the project ineligible. Seward was originally issued a letter of non-select based on the preliminary application indicating funds were to be used for acquisition. However, based on phone conversations in mid-May 2015, the application preparer was invited to submit a full application with the understanding that acquisition is not eligible, nor should the fund pay for city offices.

CUSTOMIZED JOB TRAINING

Customized Job Training provides employee training assistance to businesses that maintain, expand and diversify the state's economic base and, in the process, create or retain quality jobs for Nebraska residents.

Program priorities are:

1. Projects that result in increased investment and employment where training assistance is a significant incentive for them to be undertaken in Nebraska rather than in another state.
2. Projects that result in increased investment and employment, but no incentive is involved.
3. Projects that involve retraining existing workers to upgrade their skills as a result of new investment.

Businesses have one to three years to hire new and complete training of new or existing employees. Once the training is over, companies must maintain the baseline submitted in their applications plus all new jobs funded through Customized Job Training for two years.

In 2015, the Customized Job Training program resulted in 35 total active job training projects, of which 15 were newly awarded, and exceeded \$3.6 million. As of June 2016, DED has \$7.8 million committed to future job growth in Nebraska.

The InternNE program connects college students and employers from across the state, providing a unique opportunity for them to co-invest in the future. Interns gain valuable business experience that will help them in future careers, while successful internships help businesses develop tomorrow's leaders. Through this program, students who become interns can form lasting connections between themselves and the region.

Students can find value in these internships. Over 40% of the participating students rated their internships a 10 out of 10. Of the interns who shared their future plans in the evaluation, around 50% had said that they had been hired on as full-time employees with the companies for which they had interned.

The program sets out to create worthwhile experiences for students. To be an eligible internship, businesses must create an internship where students can gain valuable work experience, increase knowledge assisting in career decision-making, and assist the business in short-term objectives. Along with this, students must be paid at least minimum wage, and the internship must be a sufficient duration for the student to gain valuable work experience.

Under current InternNE guidelines, businesses have one full year to hire and complete internships.

At InternNE.com, there's a place to post a company's quality internships, search for candidates, and manage InternNE grant funds, all through this portal.

The InternNE program had a total of 476 projects during 2015. Of those, 307 were closed between January 1 and December 31, 2015, leaving 169 active projects at the end of 2015.

Altogether 1,222 internship positions were approved and \$4.850 million granted to the participating companies. Of the awarded positions, 814 were filled during the 2015 calendar year. The InternNE program disbursed \$2,158,674 to 476 companies with contracts that closed during 2015.

Expanding existing businesses and attracting new businesses to Nebraska communities depends on strategy and timing that sometimes includes offering shovel-ready sites or unfinished buildings standing at the ready.

The purpose of the Site and Building Development Act, introduced in January 2011 and enacted in October 2011, is to help provide industrial-ready sites and buildings statewide in an all-out effort to create "conditions favorable to meeting the industrial readiness of the state."

To meet the conditions of Neb. Rev. Stat. §149, the Site and Building Development Act, the Department is required to develop a Qualified Action Plan by January 1 of each even-numbered calendar year.

The Qualified Action Plan sets forth the activities eligible for assistance under the Site and Building Development Act. These activities have been selected by the Department to further priorities which are appropriate to local conditions and the state's economy. Funding was focused on business recruitment and expansion projects that located or expanded in Nebraska. There was one application received for first priority projects or speculative site or building projects.

The Nebraska Affordable Housing Trust Fund (NAHTF) enhances economic development in the state and provides safe, affordable housing for Nebraska's citizens. Funding is received from the revenue generated through the state's documentary stamp tax. A total of \$9,930,324 was deposited into the AHTF from January 1-December 31, 2015, which covers current obligations along with upcoming award allocations.

For the 2015 calendar year, NAHTF awarded \$7,824,510, which was matched by grantees with an additional \$2,283,698. These funds created housing opportunities as well as created employment positions.

194 housing units were created or improved with the 2015 NAHTF funds. Such units include new or rehabilitated multi-family or single family units. Many include improvements to owner occupied properties while new homebuyers were assisted as well. Current data shows that these units maintain an approximate 95% occupancy rate. A breakdown of projects completed in whole, or in part, with NAHTF funds begins on page 60. This breakdown includes those begun in 2015.

The economic development benefit afforded by the NAHTF includes the creation of 163.3 positions. These jobs may have been created at businesses that directly support the housing activities, including lenders, lumberyards, home supply stores, furniture stores, or at businesses that support the households of the tradesmen, such as grocery or retail stores. (This employment data is based on an employment multiplier from IMPLAN, an input/output model used to estimate the impact of economic activity).

Following is a sample of the success stories resulting from recently funded Nebraska Affordable Housing Trust Fund projects:

Duplex Project in Aurora Adds Needed Housing for Senior Living

Cottage Park II is a six-unit duplex project for seniors aged 55+. Each unit includes three bedrooms, two baths and approximately 1,360 sq. ft. Living rooms, kitchens and dining rooms have vaulted ceilings. The master bedroom has a cathedral ceiling, walk-in closet and spacious bath with walk-in shower. The guest bath has a tub/shower combo. Extra touches include crown molding throughout, larger base and casing.

Each unit has an attached single car garage that is finished, insulated and also includes an extra 6' X 10' storage area. Covered back porches are 6' X 11' accessed by a French door off the dining area. The Energy Star appliance package includes range/oven,





dishwasher, built-in microwave, fridge and washer/dryer.

The project was awarded funds from the NAHTF on 9/12/14, Release of Funds was on 10/24/14 and was constructed, completed and fully occupied by 6/30/15. All six units are NAHTF units constructed with \$800,000 of NAHTF funds and \$276,954 of leveraged funds.

Exteriors are landscaped with grass, plants/trees and underground irrigation. Siding is Hardie cement with brick accents. Exterior lighting is photocell controlled to turn on/off with darkness and sunlight.

Sidney Rental Housing Project Offers Four New NAHTF Program Units



Sidney's new 12-unit rental housing project consists of two attached buildings with six units in each building and was completed on September 1, 2015. Four of its 12 units (two 2-bedrooms and two 1-bedroom) are NAHTF units meeting certain affordability requirements including income restrictions, rent limitations and an affordability period.

Specifically, the four NAHTF units must be rented to households at or below 120% of the Area Median Income (AMI) and the length of period of affordability is five years.

The project officially started in March 2013 when Sidney's City Council first authorized the chief elected official to apply for the Nebraska Affordable Housing

Trust Fund (NAHTF) program and subsequently authorized the Mayor to apply to DED for a \$500,000 grant for a \$1.2 million construction loan, including the purchase of the site and construction of 12 rental housing units in the Cottonwood Addition.

The City was notified in January 2014 that it was awarded \$500,000 for the project.

The City then entered into an agreement with Grassland Apts, LLC (Jerry and Diane Steffens) to construct the 12 rental housing units, now known as the Grassland Apartments.

All NAHTF units have been occupied.

SENCA Program Helps Lale And Cindy Become Home Owners

A southeast Nebraska couple had been renting a home for seven years when they were notified that the home was going to be put up for sale. Lale and Cindy, both disabled and living on a fixed income, suddenly became unsure as to what the future would hold for them. Paying just \$350 a month for rent, they wondered if they could find a similar home for the same money. Concerned about what to do next, their daughter Tish recommended they contact the Southeast Nebraska Community Action Partnership, Inc. (SENCA). Tish told them to find out if they would qualify for any of SENCA's housing programs that were available to persons with low-to-moderate incomes.

Lale and Cindy did just that. They wanted to see if they could be the new owners of the current home they were renting. They worked with SENCA's housing program manager to complete an application and other necessary paperwork for the SENCA HOMES (Home Ownership Makes Economic Sense) program. The couple was also required to complete the SENCA Homebuyer Education program where they learned valuable information regarding the process of buying and maintaining a home of their own.

The home needed some repairs, like many of the older homes in Nebraska. Lale and Cindy qualified for the SENCA HOMES program which provided them a low-interest, deferred down-payment assistance loan and a housing rehab grant. The housing rehab grant allowed the home to become eligible for a first mortgage with a local lender.

Once approved for a first mortgage and the SENCA HOMES down-payment assistance, Cindy and Lale became homeowners. In the end, their mortgage payment ended up being \$64 a month less than what they had been paying for rent on the same home. Following the loan closing, SENCA assisted the couple through the housing rehab process to ensure needed repairs were completed. Improvements and repairs to the home included attic insulation, new exterior doors, interior doors, electrical upgrades, flooring, gutters and siding.

When asked if they would recommend the SENCA housing programs to others, Cindy replied, "Oh, Heavens yes! Without these programs offered through SENCA we may not have been able to purchase the property and keep our home."



Chadron Purchase Rehab Resale Projects



In the town of Chadron, pop. 5,787, High Plains CDC and partners made it a priority to revitalize multiple houses, which helped rejuvenate the community.

In 2014, High Plains CDC was awarded \$497,740 in NAHTF funds for home buyer Purchase Rehab Resale projects.

240 N Lake

This house, which had been unoccupied for two years, was purchased from the U.S. Department of Agriculture Rural Development. The house received plumbing work, new windows, doors, and flooring, and updated electrical wiring.

The Chadron State College Women's basketball team volunteered primed and painted the house's exterior. Pine Ridge Job Corps took out and reconstructed the front porch. A local masonry program reworked stonework on the front of the house and a fireplace. A local painting program painted the inside of the house. CSC's basketball team primed the interior of the house. Pine Ridge Job Corps had 3 different programs working on it, the cement class, the masonry class and the painting class, all taught by different instructors.

A single mother and her three children who had moved to Chadron from Rapid City, S.D., purchased the home, which was within walking distance of the upper elementary school.

A guaranteed loan with RD and Farmers State Bank and Westgate Bank, and \$5,000 closing cost assistance from High Plains CDC helped the single mother become a homeowner.

318 Shelton

Built in 1903, this home had served families throughout the years, until its deteriorating condition led to it sitting idle for several years. A couple of women finally bought it with the goal of turning it into a private counseling practice.

When High Plains CDC later purchased the house, it removed a kitchen pantry to enlarge and update the bathroom. The house received a completely new kitchen, windows, doors, flooring, and a new HVAC system as it previously had electric baseboard heat. Local contractors did the work.

The house was sold to a single man who worked for a local electrician.

A loan through Security First Bank and \$5,000 in closing cost assistance from High Plains CDC allowed him to go from renter to homeowner.

Pender's Logan Valley Cottages – Trust Fund Rentals

Logan Valley Cottages consist of one duplex (two units) located at 507 Ivan Street and one triplex (three units) located at 601-603 McCabe Street, Pender, Nebraska, population 1,035. The units are owned and managed by the Pender Community Development, (PCD).

Each unit has approximately 1,393 square feet of living space, attached garage, storm shelter, washer, dryer, range, refrigerator, dishwasher, garbage disposal, microwave and garage door opener. Lawn care, snow removal, water, sewer and trash pick-up will be provided by owner. All other utilities will be paid by the tenant. All five units are two bedroom apartments set aside for households earning at or below 120% of AMI. The interest in the units has been steady and people in the community who currently own a home are considering these units as a way to downsize. This, in turn, will improve the housing stock availability for younger families. All of the units are handicapped adaptable and meet visit-ability standards. One unit meets all requirements for Uniform Federal Accessibility Standards (UFAS).

With the completion of construction in late 2015, the rent up began. The 120% of AMI limit opened the door for more people to consider these apartments. This project definitely fills a need for the community. The community, like several in the area, has an aging demographic, therefore there is an increased interest from people to down size from their single family homes. A housing study completed in 2010 forecasted the need for additional housing in the community. DED funds have allowed additional housing to become a reality. This project may help free up larger homes occupied by a couple or single occupant to allow families to locate in Pender.

The total project cost for Logan Valley Cottages was \$814,450. Of this amount, \$732,950 was funded with Nebraska Affordable Housing Trust Funds and \$81,500 as a conventional bank loan.

Pender is excited about what these additional housing units bring to the area. Five years after these units have been fully occupied, all rent and income restrictions could cease. PCD could choose to either lease the five apartments as market rate units, or keep them reserved for low-income-tenants – whatever works best for the community. The future potential for flexibility with these five units is a bonus for the community of Pender.

PCD and Pender are grateful to DED for this program. For the past ten years, the community has been working on various ways to build affordable rental units for potential residents. With the tremendous assistance received from DED, PCD was able to provide affordable housing as well as build the units on residential lots that had been vacant for



years. This is definitely a sound project that has provided many benefits to area residents. PCD looks forward to working with DED on future projects.

Loup City's Sunset Cottages – Trust Fund Rentals

Sunset Cottages consist of one duplex and one tri-plex (five units) located at K and 11th Streets in Loup City, Nebraska, population 1,020. The units are owned and managed by Sherman County Economic Development, Inc. (SCED, Inc.)

Each unit has approximately 1,393 square feet of living space, an attached garage, storm shelter, washer, dryer, range, refrigerator, dishwasher, garbage disposal, microwave and garage door opener. Lawn care, snow removal, water, sewer and trash pick-up will be provided by owner. All other utilities will be paid by the tenant.

All five units are two bedroom apartments for households with at least one member who is 55 and older. For the first five years of occupation, households must income qualify and earn at or below 120% of AMI. For those 55 and older who qualify, these units are offering maintenance free living that is affordable. Tenants who have talked to the management office are excited about giving up yard work and maintenance on their homes. Interested households like the layout and believe these units will be safer for them to continue to live independently for a longer time. All of the units are handicapped adaptable and meet visit-ability standards.

With the completion of construction in late 2015, interest in the units has definitely increased this spring. One household has been approved for move-in and three more applications are being processed and look like they will also qualify soon.

Marketing these units has peaked interest from other families looking for affordable, quality housing in Loup City. It is anticipated that when the five households (55 and older) move into the NAHTF units, the single family homes will open up as affordable housing for other families to move into.

The total project cost for Sunset Cottages is \$796,450. Of this amount, \$716,750 was funded with Nebraska Affordable Housing Trust Funds and \$67,700 is in the form of a conventional bank loan. \$2,000 has also been invested as a donation from SCED, Inc. and \$10,000 has been invested as a grant from

the Sherman County Community Foundation.

Loup City is very excited about what these additional housing units bring to the area. Five years after these units have been fully occupied, all rent and income restrictions on these units could cease. SCED, Inc. could choose to either lease the five apartments as market rate units or keep them reserved for low-income tenants – whatever works best for the community. In addition, after five years if SCED, Inc. determines that the need in the community is greater for households other than elderly it can eliminate the elderly designation and lease the units with no age restrictions. The future potential for flexibility with these five units is a bonus for the community of Loup City.

SCED, Inc. and Loup City are grateful to DED for this program which brings affordable housing to small communities that don't always have the resources to qualify for many of the other housing programs. This program is a perfect fit for the community.



Attractive, functioning homes make towns more presentable to visitors, improve the quality of life, and increase economic stability. Most importantly though, keeping homes up to standards gives residents safe, comfortable and great places to live in.
