Please note that **Exhibit E is <u>not</u> a template; it is a reference guide** for accessing and downloading Low- and Moderate-Income Summary Data (LMISD). Use the data set to respond to application questions and upload it as part of your application. Be sure to include the specific data source used for qualification (e.g., ACS Census Data, block groups, etc.). The data sets are based on 2016-2020 ACS.

If you are a veteran user of LMI data, abbreviated refresher instructions appear on the CDBG Resource Library page, near the bottom of the screen.

If you are new to the use of LMI data, this document provides in-depth instructions for beginners as follows:

METHOD 1: If your service area comprises an entire Place (City or Village) use the ACS **All Local Governments** spreadsheet.

METHOD 2: For a geographic format, use the ACS **All Block Groups** spreadsheet. Applicants may combine geographies to best represent service areas.

METHOD 3: If your service area comprises of block groups, place (includes census designated plan, consolidated cities, and incorporated places), county subdivisions, and county, use the **ACS Map Application** tool.

If you are unfamiliar with census groups, tracts and blocks, please refer to the Nebraska CDBG Administrator Manual, Appendix Section 1¹, and HUD Notice CPD 24-04.²

To qualify a project activity under the national objective of benefiting low- and moderate-income (LMI) persons on an **area basis (LMA), at least 51% of the residents in the service area must be LMI,** according to the most recent 5-year American Community Survey (ACS) data.

LMISD is based on the American Community Survey (ACS) data and summarizes data on percentage of LMI residents by census tract/block group. Based on a multitude of factors, this summary data may not always be appropriate in making the determination for an activity's service area(s). Such instances include where the area that will be served by an activity is not coterminous with census tracts, block groups, or other officially recognized boundaries, but also where events have occurred giving reason to presume the data is no longer accurate (e.g. closing of a major employer, annexation, etc.). For additional guidance on income surveys and survey methodology, see appendices.

The activity's service area does not need to be consistent with census tracts or other officially recognized boundaries, but it must be the entire area served by the activity. Activities of the same type that serve different areas must be considered separately on the basis of their individual service areas.³

Follow the instructions in this exhibit to determine eligibility. Census resources are available online:

METHOD 1: If your service area comprises an entire Place (City or Village) use the ACS **All Local Governments** spreadsheet.

The *place* geography reflects the jurisdiction of a city, town, or other place. In rural settings, the place geography typically reflects UGLG jurisdictions and lends well to qualifying for area benefit for activities benefiting the whole town.⁴

- 4. Open the XLS file. Apply a filter to the STUSAB column to display only the state of Nebraska's results.
 - Click the "funnel" filter button. *Un*check **Select All** (box at the top of the list). Then check only the box in front of NE (for Nebraska). Click **OK** button.



5. Calculate the community's LMI-related numbers. Scroll down or search (CTRL+F keys) to locate the correct city, village, or county applicant.

 - Note:
 - i. In the screenshot, only *one community* would qualify via LMA with a percentage of 51% or higher (rounding is never allowed).
 - ii. If the community is quite close but just *below* the 51% requirement, it may be a good candidate to **consider conducting a community income survey**, whose results are valid for a 5-year period.

- This method may be used if a grantee believes that the data are not current or do not provide enough information regarding income levels in the entire service area.
- Two methods include: 1) Census Income Survey or 2) Random Sample Income Survey.

- Take a screenshot of this full census data screen (all columns) or export the data.
- Save the file.
- Use this data to answer the application questions.
- Upload the source documentation to the application.

- If duplicate/multiple results display, click any item listed. This likely indicates that the Place comprises multiple census blocks.
- 5. Click on a census area. A map with line segments (displaying one or more block groups) will load on the left side of the screen.
 - Carefully click once within the selected portion of the map for which you need to determine census information.
 - A. Aqua indicates the portion of the map that's been selected.
 - B. A pop-up box will display information for that block.
- 6. Determine census data for this area.
 - This step may need to be repeated if necessary to gather the required information for all block groups that are part of the project's service area.

Tips:

- Note the "1 of 4" and the <> arrows that scroll through a place's various blocks.
- You may need to scroll down to view key data for each block.

Method 3 Important Notes:

- Grantees may combine geographies to best represent service areas, typically by combining two or more block groups. When using multiple geographies in the determination of LMA compliance of a service area, grantees are reminded that percentages shall not be averaged across multiple geographies.
- Grantees should not define a single service area by compiling a mix of place and block group data.
 These geographic layers often have overlapping areas. If a service area was constructed by mixing block group and place data, residents would likely be double-counted.⁵
