

CDBG-DR INFRASTRUCTURE MATCH FOR HAZARD MITIGATION GRANT PROGRAM (HMGP) PRE-APPLICATION

Introduction: As outlined in the CDBG-DR Action Plan, the Nebraska Department of Economic Development (DED) has recognized the need to fund the local match of both the Public Assistance (PA) and Hazard Mitigation Grant Program (HMGP) in connection with DR-4420 through HUD's CDBG-DR dollars allocated to the State. Under the Hazard Mitigation Grant Program (HMGP), FEMA reimburses up to 75% of the total project cost for any eligible project. The remaining 25% is typically funded by the Subrecipient (referred to here as the "local share"). The Infrastructure Match Program will reimburse the local share of eligible HMGP projects.

The purpose of the Pre-Application is to initially capture project status, eligibility, and the local match need of Hazard Mitigation Grant Program (HMGP) Projects. <u>This is simply the first step and does not constitute an application or an award.</u>

Directions to Sub-Applicants: Sub-Applicants have until Friday, June 10, 2022, to submit the CDBG-DR Infrastructure Match Program for HMGP Pre-Application to DED. Interested **HMGP Applicants** should from DED request secured link via а ded.cdbgdr@nebraska.gov to submit the attached Pre-Application, filling it out in its entirety. If Low - and Moderate - Income (LMI) and HUD-defined Most Impacted and Distressed (MID) funding requirements described in the CDBG-DR Action Plan and Infrastructure Match Program Guide are not able to be met by the potential projects submitted through the NOI process, DED reserves the right to pause the NOI process and reevaluate the CDBG-DR Infrastructure Match Program as a whole. DED could reopen the NOI release period for as long as is deemed necessary to meet LMI and HUD-defined MID funding requirements.

Sub-Applicants seeking local match through the CDBG-DR funding must fill out the Pre-Application in its entirety and provide the requested attachments (noted for specific questions). Please note that some projects may not be funded, even if eligible.

 A new tab will open to the HUD Web Mapping Application. In the top right corner, click on "View Application". A map of the United States will appear.





• In the top right corner, enter a county or city located within the Area of Benefit and press enter to search. The map will zoom to the searched area.






In the top left corner, click on the Layer button (which looks like a stack of papers).
 Uncheck the LMISD by Place, LMISD by County Subdivision, and LMISD by County boxes. Only one box should remain checked – LMISD by Block Group.
 Click the X to close the layer box.




• In the top left corner, click on the Service Area button (which includes a pointer arrow icon). In the "Select" box, click on the downward arrow to select shape style. Be sure to leave this box open while you highlight the block groups within your project's Area of Benefit.






 Highlight all block groups within the Area of Benefit. Leave the Service Area box open while you highlight the block groups within the Area of Benefit or you may only be able to select one block group at a time, instead of selecting the complete Area of Benefit.

In the Service Area box, click on the "..." to the right of "LMISD by Block Group."
