Narratives

Disaster Damage:

After record-setting low temperatures that created frost depths approximately two feet deep and ice on rivers and creeks in winter of 2018-2019, Winter Storm Ulmer, a bomb cyclone – or "winter hurricane," a term given to a rapidly intensifying storm – roughly equivalent in power to a Category 2 hurricane, moved across Nebraska between March 12 and 15, 2019. Recorded wind gusts during the cyclone approached 80 mph in many parts of the state and contributed to blinding blizzard conditions that closed highways and stranded motorists. Many roads and bridges, and other infrastructure, were damaged such that they were "out of service" or impassable for a considerable amount of time, causing remarkable disruption.

The bomb cyclone also brought heavy snow, blizzard conditions, rainfall, and above-freezing temperatures into much of the interior of the US. This part of the country already had significant snowpack on the ground due to above-average precipitation during the 2018-2019 winter season. Nebraska experienced its worst flooding event in 50 years between March and July 2019. As temperatures warmed in April and May 2019, the heavy snow and excessive rainfall from the 2018-2019 winter season contributed to rapid melting of ice and snow, resulting in flooded rivers and ice jams that breached levees, damaged infrastructure, and destroyed thousands of homes and businesses. The eastern side of the state was particularly impacted by flooding, resulting in fatalities, evacuations, and search and rescue missions.

In many areas, the flood damage was exacerbated by thick river ice breaking off in an atypically severe manner. Bridges were washed away by flooding or rendered impassable due to accumulated ice chunks.

Recovery Needs:

Grantees who receive an allocation through the CDBG-DR program are required to conduct an Unmet Needs Assessment (UNA) to assist in the identification and prioritization of critical unmet needs following a disaster and to identify long-term recovery efforts that will mitigate against future disasters. For DR-4420, the State of Nebraska's UNA, as carried out and completed for the Initial Action Plan, identified \$269,043,934 in unmet need, specifically \$55,637,821 in unmet housing need, \$196,163,422 in unmet infrastructure need, and \$17,242,691 in economic revitalization need. Throughout the State, recovery efforts have been taken and continue to be initiated for public and private housing and infrastructure facilities. During the development of the Initial Action Plan, local jurisdictions reported having completed repairs on homes that were damaged or destroyed as well as repairing infrastructure facilities. However, additional need remains.

As a result of the UNA process, Nebraska plans to establish funding opportunities in the following core sectors to assist in its disaster recovery:

- 1. Infrastructure
- 2. Housing
- 3. Planning

Nebraska's CDBG-DR program and funding opportunities are not designed or intended to create Program Income (PI) nor establish revolving loan funds (RLFs).

Low- and Moderate-Income (LMI) and Vulnerable Populations. Nebraska will prioritize activities under the housing programs that benefit LMI households, persons experiencing homelessness, and individuals requiring supportive housing, as identified in 24 CFR 91.315(e). Prioritization of vulnerable populations aligns with applicable Fair Housing requirements.

<u>Most Impacted and Distressed (MID) Areas</u>. Dodge, Douglas, and Sarpy counties will be the target for 80% of available CDBG-DR funding.HUD requires that 80% of CDBG-DR funds be allocated and spent in HUD-defined MID areas. HUD originally identified the MID areas as being the entirety of Sarpy County, zip code 68025 (Fremont, Inglewood, and Woodcliff) in Dodge County, and zip codes 68064 and 68069 in Douglas County (Valley and Leshara). Based on the UNA, Nebraska expanded the HUD-defined MID to include all of Dodge County and Douglas County.

Infrastructure Needs will be supported via the Infrastructure Match Program. Funding will be available to local jurisdictions for FEMA and non-FEMA projects. As the Initial Action Plan UNA and HUD's early assessments both indicated, DR-4420 generated catastrophic impacts to infrastructure, resulting in significantly higher losses in that core category than economic and housing needs. Infrastructure damage was widespread, with 84 out of 93 counties and four tribal areas impacted, reporting damage to roads, bridges, levees, dams and many other critical infrastructure facilities. To address the extensive infrastructure needs within the state, the state is prioritizing CDBG-DR funding under DR-4420 for infrastructure recovery. However, following the launch of the Infrastructure Match Program, designed to support local jurisdictions by making available CDBG-DR funding to pay the requisite local cost-share towards FEMA Public Assistance (PA) and Hazard Mitigation Grant Program (HMGP) projects, the actual amount requested by applicants was significantly less than anticipated. While there were over 300 applications for funding, nearly one-third were ineligible and over 80 percent of those projects determined initially eligible for DR funding were for amounts less than \$50,000. During the implementation process, other infrastructure projects not funded with FEMA were identified.

<u>Housing Needs</u> will be supported via the Affordable Housing Construction Program. As part of the Initial Action Plan, to determine how many housing units would require funding through the CDBG-DR program, DED conducted a data analysis to review the total number of homes served through existing State housing programs. DED estimated the total remaining unmet need in both the HUD MID and state MID areas to be 252 housing units. Upon the launch of the Affordable Housing Construction Program, the interest in funding to support construction of housing exceeded expectations. Thus, DED reallocated costs from undersubscribed programs to support that demand.

<u>Planning and Capacity Building</u>. Nebraska recognizes the importance of strong planning efforts to achieve equitable, effective, and sustainable long-term recovery. Therefore, has allocated funding for planning activities to further analyze and address flood hazard vulnerabilities that led to flood damages under DR-4420; and support an effective and resilient recovery from the disaster.

Overall Progress Narrative:

Progress Overview QPR-2024 Q4, September 30 - December 31, 2024.

DED is on track to meet program targets for HUD-MID investments. Investments in larger service area infrastructure projects may make meeting the LMI target a challenge. We are assessing our options and may request a waiver in accordance with the Universal Notice.

No additional application cycles are anticipated nor planned at this time. Similiarly, there no anticipated amendments to the public-facing action plan; APA3 is the current version being implemented. No new programs nor NOFOs are anticipated at this time. Summaries by core element are included below, refer to individual activities for more details.

DED continues to evaluate and maintain program materials and SOPs, including those specific to activity delivery. DED continues to draw down certain documented ADCs against activities.

NOTE: DED completed a voucher revision to address a data entry error discovered as part of completing the QPR. No overpayment is associated with the data entry error. The revisions were administrative and involved a voucher created, approved, and processed during 2024 Q4. However, upon submitting the revisions in DRGR, the financial data did not update overnight to reflect the adjustments to voucher line items. This may be attributed to a temporary Federal funding pause. DED will make the necessary corrections in a future QPR. Several activities were affected.

<u>PLANNING</u>: expenditures for planning costs continued. In Q4 2024, DED successfully launched two HRP awards and oversaw the completion of phase one of the RARP award. The HRP awards were formalized through subrecipient agreements with the City of Bellevue and Village of Niobrara, and both awardees have prepared RFPs and are progressing toward their milestones, as more particularly described in the respective Activity sections below. The RARP awardee, the University of Nebraska- Lincoln, has continued research and development, including organizing a collaboration meeting with over 50 stakeholders, launching a new website, submitting multiple research papers, and presenting findings at local and national conferences.

INFRASTRUCTURE: expenditures for project costs and activity delivery costs (ADCs) continued. During 2024 Q4, the DED Infrastructure Match Program reimbursed eligible FEMA Public Assistance (PA) Match projects and Hazard Mitigation Grant Program (HMGP) Match projects. HUD provided and DED successfully received all outstanding AUGFs, and supplemental documentation has been appropriately filed in the respective project records.

documentation has been appropriately filed in the respective project records. In addition to conducting multiple technical assistance (TA) meetings with local jurisdictions for needed procurement documentation, reporting requirements, and monthly check-in sessions to address any other needs, the Infrastructure Program Manager continues to maintain program guidance documents and SOPs.

We are experiencing some delays due to contractor availability. Specifically, the HMGP Elevation projects in Dodge and Platte counties are facing challenges in securing a contractor to complete the construction SOW.



<u>HOUSING</u>: expenditures for project costs and ADCs continued. All activities as of this QPR will meet LMI. In addition to processing payments for Project Costs and conducting formal TA sessions for twelve (12) awards, the Housing Program Manager continues to maintain program guidance documents and SOPs.

HOUSING, CONSTRUCTION CLOSE OUT: Two (2) low-income housing tax credit (LIHTC) housing projects have completed construction and received the certificate of occupancy. The Housing Program Manager has conducted an initial monitoring visit and working with the property management team on compliance and reporting for the affordability period which will commence when the project which should receive its 8609 and LURA in Q1. The Housing Program Manager is working with additional LIHTC projects that are close to 100% construction completion and lease-up to schedule their initial monitoring visits in Q1.

HOUSING, SMALL RENTAL: The Housing Program Manager provided regular technical assistance (TA) check-ins with developers to support projects during due diligence phases. DED expects to execute awards in Q1 and Q2 2025. Small Rental includes two (2) projects located in the State-MID (not HUD-MID).

HOUSING, LIHTC: DED executed four (4) low-income housing tax credit (LIHTC) multi-family award agreements in Q4 totaling 262 units of which 235 benefit low-to-moderate income households at or below 60% AMI. All projects are in the HUD-MID. DED expects to execute two (2) CDBG-DR awards in Q1 2025.

HOUSING, HPP: this program continues to be a challenge to implement. One award was terminated by mutual agreement this quarter. However, the Housing Program Manager continues to provide technical assistance to the others as they work through Environmental Reviews and other conditions. DED expects to execute award agreements in Q1 2025.

Project Description: The study aims to not only provide safe and affordable housing for low-to-moderate income (LMI) families, but also to give them better access to information about flood zones, building costs, and land development areas. Each participating community in the project will have specific strategic plans and housing development documents created to assist community leaders and the Knox County Development Agency in increasing the supply of resilient and affordable housing in the area. The project will include a planning committee conducting community housing surveys and blight studies, analyzing flood plains and community resource mapping in participating Knox County communities, identifying infill lots and potential housing subdivisions, creating housing concepts and cost estimates, and developing organizational infrastructure that will be utilized for the development of an affordable housing LLC template.

Location Description:

Niobrara, Verdigre, Verdel, Santee, Center, and Creighton, and areas of the Santee Sioux Reservation.

Activity Progress Narrative:

In Q4 2024, the Village of Niobrara began work on the award and completed the subrecipient agreement, initial capacity assessment worksheet, and environmental review. The project team developed and distributed a Request for Proposals (RFPs) for planning and engineering services on November 20, 2024, with a return date

and draft a request for proposals for the development of the Housing Resilience Plan. The RFP was published on December 27, 2024, with a submittal deadline of January 27, 2025. As part of the release, the City published the RFP on the City's website, APA dashboard, and distributed the RFP directly to previously utilized consultants.

Planned - As the deadline for submissions approaches, the city is also working to execute an Interlocal Agreement with the City of Papillion for the CDBG-DR Housing Resilience grant project.

Activity Description:

Risk Awareness and Resilience Planning will use CDBG -DR funding for the reduction of risk resulting from private levee failure and other flood risks and vulnerabilities. This activity will be carried out in coordination with the University of Nebraska-Lincoln.

Activities in support of Risk Awareness and Resilience Planning (RARP) will target areas with risk exposure, particularly those residential areas with risk exposure from private levees. The activities will target counties that received a disaster declaration under DR-4420 and focus on flood hazard vulnerabilities that led to flood damage under DR-4420. The overarching goal of the program is to promote comprehensive community resilience, resulting in a built environment that is more resilient to the impacts of natural disasters. The activities are intended to identify flood risk and vulnerabilities in counties that were declared under DR-4420. In support of these goals, DED may use the resulting adoption of local or regional plans, codes, and/or ordinances as scoring criteria in other CDBG-DR or other federal or state programs it administers.

Location Description:

HUD-defined MID area is the primary focus, so 100% of this activity is allocated to the HUD-MID.

DED anticipates identifying and targeting three communties within the HUD-MID, one from each identified county, to carryout planning processes. Given the nature of flood and floodmapping, DED leaves open the possibility that some elements of these planning activities may spill over into state-defined MID areas. Should that occur, it will be so documented and any costs tracked accordingly.



Activity Progress Narrative:

As we wrap up phase one and the first year of this two-year award, the UNL team continues to make outstanding progress on the RARP award implementation. On November 01, 2024, the team held a collaboration meeting where over 50 local stakeholders connected to share information and resources regarding disaster recovery and resilience in their communities. The team submitted multiple research papers and presented findings at the League of Nebraska Municipalities annual conference on October 02, 2024, at the Nebraska Planning and Zoning Association Fall Virtual Workshop on October 09, 2024, and at the national ACSP 64th Annual Conference on November 07, 2024.

The team also launched a new website this quarter, located at: https://sites.google.com/view/floodresiliencene/home. This website features an interactive story map available in both English and Spanish versions, which provides detailed information about the project and its impacts on local communities that were affected by the 2019 flooding disaster, including demographics maps to help convey and address outsize impacts of such disasters on vulnerable populations.
