## **MEMORANDUM**

# Urban Redevelopment Act Guidance

This Policy remains effective until it is amended, superseded, or rescinded.

# **SUBJECT: Urban Redevelopment Act Qualified Locations**

This guidance document is advisory in nature but is binding on the Department of Economic Development (DED) until amended. A guidance document does not include internal procedural documents that only affect the internal operations of DED and does not impose additional requirements or penalties on regulated parties or include confidential information or rules and regulations made in accordance with the Administrative Procedure Act. If you believe that this guidance document imposes additional requirements or penalties on regulated parties, you may request a review of the document.

#### ISSUE:

I. Which census tracts, located in Economic Redevelopment Areas (ERA), are qualified locations for purposes of the Urban Redevelopment Act?

#### **ANALYSIS:**

I. Nebraska Revised Statute §77-6912 defines qualified location in part as:

Any location in a city of the metropolitan class or a city of the primary class that is used or will be used by the taxpayer to conduct business activities and that is located within an economic redevelopment area.

II. Nebraska Revised Statute §77-6906 defines Economic Redevelopment Area (ERA) as:

An area in the State of Nebraska in which:

- (1) The average rate of unemployment in the area during the period covered by the most recent federal decennial census or American Community Survey 5-Year Estimate by the United States Bureau of the Census is at least one hundred fifty percent of the average rate of unemployment in the state during the same period; and
- (2) The average poverty rate in the area is twenty percent or more for the federal census tract in the area.
- **III.** Nebraska Revised Statute §15-101 states in part:

All cities having more than one hundred thousand and less than four hundred thousand inhabitants as determined by the most recent federal decennial census or the most recent revised certified count by the United States Bureau of the Census shall be known as cities of the primary class.

**IV.** Nebraska Revised Statute §14-101 states in part:

All cities in this state which have attained a population of four hundred thousand inhabitants or more as determined by the most recent federal decennial census or the most recent revised certified count by the United States Bureau of the Census shall be cities of the metropolitan class and governed by sections 14-101 to 14-2004.

#### **CONCLUSION:**

I. For Urban Redevelopment Act applications with Application Dates on or after July 1, 2022, the following census tracts, located in Economic Redevelopment Areas, are designated as qualified locations:
