



## **CDBG AmpliFund Application Guide**

2022 Community Development Block Grant (CDBG)

Browser: Log into AmpliFund, https://ne.amplifund.com using Google Chrome, Mozilla Firefox, or Microsoft Edge.

For Program Specific questions (eligible projects, matching requirements, etc.), please see the Application & Program Guidelines.

#### **NOTE** for External Users

If you are an External User applying on behalf of another organization, you need to be added as a user to the applicant organizations account and have 'Applicant Portal Access'. See the "External User Guide" and the "How to Add Users in the Recipient Portal" user guides for more information. You will then toggle to the applicant organization's account. After verifying that you are in the correct account, navigate to the applicant portal.


## How to Apply to the 2022 CDBG Opportunities

If applying for the 2022 CDBG grant, complete the following steps to register in the portal.

- Click on the link to the 2022 CDBG application provided by the Nebraska Department of Economic Development.
- 2. Locate and click on the Apply button in the top right-hand corner



- 3. The below screen will populate, the user is prompted to either Register or Log In
  - a. If you do not already have an AmpliFund username and password, click Register
    - i. See these user guides for instructions on the DED AmpliFund FAQ page
      - 1. Registering for the Applicant Portal
      - 2. How to Add Users in the Applicant Portal
  - b. If you have an existing AmpliFund username and password, enter your Email and Password, and click **Log In**




Note: If you chose **Register**, you will be brought back to the 2022 CDBG program page upon completing registration. Once again, click the Apply button to begin the application





The application progress is displayed at the top of every page. The user can also navigate to any page in the application by clicking the icon above the page's name in the progress bar. If a page is required for submission, an asterisk will appear next to the page name in the progress bar.



## **Completing the Project Information Section**

#### **Application Information section**

- 4. Enter a name for the application within the **Application Name** field. Do not use the phrase "City of" or "Village of". **Enter**: Local Unit of Government, 2022 Opportunity Name Application
  - a. Example: York, 2022 DTR Application
  - b. Example: McCook, Company ABC, 2022 ED Application
  - c. Example: Monroe, 2022 PP Application
  - d. Example: Columbus, 2022 PW Facilities Application
  - e. Example: Chadron, 2022 PW Infrastructure Application
  - f. Example: Red Cloud, TD Attraction Name, 2022 TD Application
  - g. Example: Ogallala, 2022 JT Application
- 5. Enter the amount of grant funds the Applicant is requesting in the Award Requested field.
- 6. Enter the amount the Applicant is matching in the Cash Match Contributions field.

#### **Primary Contact section**

The fields in the Primary Contact section will auto-fill with the details of the user currently logged into AmpliFund. Enter information in any remaining blank fields about the logged in user, referred to as the Primary Contact.

\*Fields marked with an asterisk are required

- 7. Enter the first and last name of the Primary Contact person in the Name field
- 8. Enter the email address of the Primary Contact person in the Email Address field
- 9. Enter the number and street name in the Address Line 1 field
- 10. Populate the City, State/Province and Postal Code fields accordingly
- 11. Once all required fields are populated, please click Mark as Complete

Note: In order to successfully submit an application, all sections must be marked as Complete

12. To move on to the next section of the application, click Save and Continue




# **Completing the Application Forms Section**

#### The Application Forms section contains CDBG Application Forms and Exhibits:



- 13. Each form needs to be clicked on, filled in per the instructions, and then Marked as Complete when finished.
- 14. If the Application Form is partially completed, the user may save changes and return later, click the **Save** button located on the bottom of the form.






#### 15. The 'Status' column indicates the progress of each application form

- New: Application Form has not yet been clicked on. All forms will appear as 'New' the first time the user accesses the application
- In Progress: Application Form has been partially completed, and Saved
- Complete: All required fields have been entered on an Application Form, and the form has been Marked as Complete

#### 16. Printing Forms

Each form can be printed individually by clicking the 'Print' icon located in the same row of the form



\*Note: Applicants will have the ability to print a completed version of the application in its entirety before final submission

17. Each Application Form must be "Marked as Complete" to successfully submit an application





#### The 2022 CDBG Exhibits are located in the Application Forms section of the application:

- 18. Each Exhibit can be completed electronically
- 19. Access each Exhibit by clicking on the Exhibit Name
- 20. Some Exhibits contain a filtering question to help determine if the Exhibit needs to be completed for the application



- 21. If the Exhibit does not need to be completed, click 'No'
- 22. The form will need to be Marked as Complete even if 'No' is indicated.

Note: You will not be able to submit your application if all application forms, including Exhibits, are not Marked as Complete





#### How to Complete an Exhibit:

#### Exhibit E1: LMI - Area Basis (LMA), Census Income Survey

To document that the CDBG activity meets the national objective of LMA, complete one of the following forms: Exhibit E, Exhibit E1, and Exhibit E2.

Complete Exhibit E1 if the service area qualifies based on the completion of a census survey.

- 28. Access the Budget section by clicking the circle labeled Budget at the top of the page
- 29. The Budget will display Categories that all proposed costs should be entered against:



- 30. Begin entering line items for each Category, by clicking on the green '+' next to the Category name
- 31. A window will appear allowing the user to enter the details for each line item



- 32. Follow the instructions on how to complete the line items for each category
- 33. Type in the line item name in the Name field
  - Ex: Engineer and Inspection
- 34. Enter the total amount of the line item (Grant Funded + Match) in the Direct Cost field

Ex: Grant Funded Amount = \$7,500, Match Amount = \$2,500.00, the Direct Cost should be \$10,000

- 35. If including cash match in the line item, for the Non-Grant Funded dropdown, select 'Yes'
- 36. In the Cash Match field enter the dollar amount of Cash Match to meet the minimum Match requirement
- 37. Click Create to save the line item
- 38. Repeat steps 1-9 for all line items associated with the application
- 39. Once the Proposed Budget template is completed in its entirety, click the Mark as Complete button.







#### **Budget Guidance**

When completing a budget for a CDBG project, include as much detail to provide the Department a full understanding of how the applicant determined the project costs and the proposed use of federal funds.

40. Create multiple line items. Do not group all expenses into a generic category line item.



41. Provide detail with a well-defined description for each line item in the narrative field.







## **Submitting the CDBG Application**

When the application is ready to submit, click on the Submit button at the top of the page

From the Submit page, the user will be able to:

- 42. Download and Review the completed application before or after submission
- 43. Jump to any of the application sections to review the answers by utilizing the timeline at the top of the page
- 44. Submit the application

#### How to Download and Review the Application

45. Click the green Review button to download a PDF of the completed application

#### **How to Submit Application**

- 46. In order to Submit the application to the Nebraska Department of Economic Development, all sections and application forms must be Marked as Complete.
- 47. Verify that all sections and application forms have been Marked as Complete by referencing the timeline at the top of page and ensuring there is a check in each section
- 48. When all sections have been Marked as Complete, submit the application by clicking on the green **Submit** button

#### **Successful Submission**

- 51. Once the application has been successfully submitted, a success message will appear on the screen and the user, who submits the application, will receive an email identifying the date and time of CDBG application submission
- 52. Once the application has been submitted, no changes can be made to the application, but it can be accessed and viewed at any time by logging back into the Applicant Portal at <a href="https://ne.amplifund.com">https://ne.amplifund.com</a>
