#### **Narratives**

#### **Disaster Damage:**

After record-setting low temperatures that created frost depths approximately two feet deep and ice on rivers and creeks in winter of 2018-2019, Winter Storm Ulmer, a bomb cyclone – or "winter hurricane," a term given to a rapidly intensifying storm – roughly equivalent in power to a Category 2 hurricane, moved across Nebraska between March 12 and 15, 2019. Recorded wind gusts during the cyclone approached 80 mph in many parts of the state and contributed to blinding blizzard conditions that closed highways and stranded motorists. Many roads and bridges, and other infrastructure, were damaged such that they were "out of service" or impassable for a considerable amount of time, causing remarkable disruption.

The bomb cyclone also brought heavy snow, blizzard conditions, rainfall, and above-freezing temperatures into much of the interior of the US. This part of the country already had significant snowpack on the ground due to above-average precipitation during the 2018-2019 winter season. Nebraska experienced its worst flooding event in 50 years between March and July 2019. As temperatures warmed in April and May 2019, the heavy snow and excessive rainfall from the 2018-2019 winter season contributed to rapid melting of ice and snow, resulting in flooded rivers and ice jams that breached levees, damaged infrastructure, and destroyed thousands of homes and businesses. The eastern side of the state was particularly impacted by flooding, resulting in fatalities, evacuations, and search and rescue missions.

In many areas, the flood damage was exacerbated by thick river ice breaking off in an atypically severe manner. Bridges were washed away by flooding or rendered impassable due to accumulated ice chunks.

#### **Recovery Needs:**

Grantees who receive an allocation through the CDBG-DR program are required to conduct an Unmet Needs Assessment (UNA) to assist in the identification and prioritization of critical unmet needs following a disaster and to identify long-term recovery efforts that will mitigate against future disasters. For DR-4420, the State of Nebraska's UNA, as carried out and completed for the Initial Action Plan, identified \$269,043,934 in unmet need, specifically \$55,637,821 in unmet housing need, \$196,163,422 in unmet infrastructure need, and \$17,242,691 in economic revitalization need. Throughout the State, recovery efforts have been taken and continue to be initiated for public and private housing and infrastructure facilities. During the development of the Initial Action Plan, local jurisdictions reported having completed repairs on homes that were damaged or destroyed as well as repairing infrastructure facilities. However, additional need remains.

As a result of the UNA process, Nebraska plans to establish funding opportunities in the following core sectors to assist in its disaster recovery:

- 1. Infrastructure
- 2. Housing
- 3. Planning

Nebraska's CDBG-DR program and funding opportunities are not designed or intended to create Program Income (PI) nor establish revolving loan funds (RLFs).

Low- and Moderate-Income (LMI) and Vulnerable Populations. Nebraska will prioritize activities under the housing programs that benefit LMI households, persons experiencing homelessness, and individuals requiring supportive housing, as identified in 24 CFR 91.315(e). Prioritization of vulnerable populations aligns with applicable Fair Housing requirements.

<u>Most Impacted and Distressed (MID) Areas</u>. Dodge, Douglas, and Sarpy counties will be the target for 80% of available CDBG-DR funding.HUD requires that 80% of CDBG-DR funds be allocated and spent in HUD-defined MID areas. HUD originally identified the MID areas as being the entirety of Sarpy County, zip code 68025 (Fremont, Inglewood, and Woodcliff) in Dodge County, and zip codes 68064 and 68069 in Douglas County (Valley and Leshara). Based on the UNA, Nebraska expanded the HUD-defined MID to include all of Dodge County and Douglas County.

Infrastructure Needs will be supported via the Infrastructure Match Program. Funding will be available to local jurisdictions for FEMA and non-FEMA projects. As the Initial Action Plan UNA and HUD's early assessments both indicated, DR-4420 generated catastrophic impacts to infrastructure, resulting in significantly higher losses in that core category than economic and housing needs. Infrastructure damage was widespread, with 84 out of 93 counties and four tribal areas impacted, reporting damage to roads, bridges, levees, dams and many other critical infrastructure facilities. To address the extensive infrastructure needs within the state, the state is prioritizing CDBG-DR funding under DR-4420 for infrastructure recovery. However, following the launch of the Infrastructure Match Program, designed to support local jurisdictions by making available CDBG-DR funding to pay the requisite local cost-share towards FEMA Public Assistance (PA) and Hazard Mitigation Grant Program (HMGP) projects, the actual amount requested by applicants was significantly less than anticipated. While there were over 300 applications for funding, nearly one-third were ineligible and over 80 percent of those projects determined initially eligible for DR funding were for amounts less than \$50,000. During the implementation process, other infrastructure projects not funded with FEMA were identified.

<u>Housing Needs</u> will be supported via the Affordable Housing Construction Program. As part of the Initial Action Plan, to determine how many housing units would require funding through the CDBG-DR program, DED conducted a data analysis to review the total number of homes served through existing State housing programs. DED estimated the total remaining unmet need in both the HUD MID and state MID areas to be 252 housing units. Upon the launch of the Affordable Housing Construction Program, the interest in funding to support construction of housing exceeded expectations. Thus, DED reallocated costs from undersubscribed programs to support that demand.

<u>Planning and Capacity Building</u>. Nebraska recognizes the importance of strong planning efforts to achieve equitable, effective, and sustainable long-term recovery. Therefore, has allocated funding for planning activities to further analyze and address flood hazard vulnerabilities that led to flood damages under DR-4420; and support an effective and resilient recovery from the disaster.

## **Overall Progress Narrative:**

Progress Overview QPR-2024 Q1, January 1 - March 31, 2024

Following the approval of APA3 and as noted in the last QPR narrative, DED made updates to funding program materials (e.g., program guides, marketing, technical assistance materials) impacted by the changes made under APA3. These efforts also included updating the DRGR Action Plan in accordance with APA3, a substantial amendment approved by HUD on January 3, 2024. In addition to changes to the Project and Activities to reflect the reallocations under APA3, revisions were made to the Recovery Needs narrative of the DRGR Action Plan. One Project was added and the following Projects were removed (i.e., deleted): DR-19-HAP, DR-19-HRP, and DR-19-RAP. The newly added Project combines all Planning activities under a single Project. Per APA3â¿¿s Record of Changes, this was a "Substantial Amendment. Moved \$15.0M from Infrastructure Match Program to the Affordable Housing Construction Program; removed plans for the Housing Assistance Program and moved its budgeted \$11.0M to the Affordable Housing Construction Program; added additional flexibility for Planning activities. Incorporated Summary of Changes documents, which describe each amendment and, where applicable, record of public comment, as Appendix E."

DEDâ¿¿s CDBG-DR website was updated with revised program materials, all revisions are noted and acknowledged by version number and summary of changes is recorded in the respective Record of Changes to each document.

DED is still in the process of establishing a procedure for revising vouchers to reallocate costs initially charged against Admin (PACs) to the appropriate DRGR activity; this includes reallocating ADCs.

DED is on track to meet program targets for LMI and HUD-MID investments. Program eligibility and resources in DRGR assist in tracking these targets.

<u>Planning</u>: DED is in the process of launching a NOFO and application portal for Housing Resilience Planning activities. This is planned to be delivered through subrecipient agreements.

See additional progress information in the Activity narrative for Risk Awareness and Resilience Planning and Action Plan, respectively.

Housing: Following last quarterâ¿¿s ongoing direct outreach, DED awarded an additional two (2) projects for the AHCP-Homeownership Production Program (HPP) totaling \$2,550,000 in funding for seventeen (17) single-family homes. These HPP awards were announced in February and included Habitat for Humanity Fremont in Fremont (Dodge County) building four (4) single-family, in-fill homes and Housing Foundation for Sarpy County in Bellevue (Sarpy County) building thirteen (13) singlefamily homes as part of a larger development.

DED joined the Governor, Mayor of Bellevue, Executive Director of Housing Foundation of Sarpy County, and community leaders to announce Sarpy Countyâ¿is award on March 9, 2024. Sarpy County, particularly the City of Bellevue, experienced severe housing damage from the floods related to Winter Storm Ulmer, DR-4420.

Technical assistance for completing the due diligence process is ongoing for the first HPP application selected, as well as the two latest awards including the Enironmenl Review process. DED does nt anticipate an additional HPP application cycle.

In January, the DR Housing Program Manager finalized review and scoring for the 4% LIHTC 2024 application cycles in alignment with NIFAâ¿¿s QAP via the joint application process. Out of a total of eleven (11) applications, five (5) applications requested CDBG-DR funds, equating to \$20M with total project costs of over \$232M. On March 22, DED, alongside NIFA, announced the award of \$4,000,000 to two (2) 2024 4% LIHTC projects to build more than 200 affordable housing units in the HUD-MID. These awarded projects include Southside Terrace Phase 2 (Omaha, Douglas County) and Tallgrass Bond (Papillion, Sarpy County).

Following the technical assistance webinar held in 2023-Q4, DED held a Small Rental Application Overview on March 21 providing attendees a brief review of the program guidelines, as well as an outline and walkthrough of the application, scoring criteria, and timeline. Small Rental Application launched the following day, March 22.

DR Housing Program Manager attended a session in partnership with NIFA providing technical assistance to potential applicants ahead of the 2025 9% LIHTC joint applications due in 2024-Q2. DED will join NIFA for future sessions through Q2, which aligns with the last scheduled funding round for CDBG-DR funding availability via the joint application process (AHCP-LIHTC).

The regular technical assistance âiicheck-insâii with developers have proved successful and continue to be scheduled to support awarded projects pre-funding agreement.

In Q1, DED processed four (4) payment requests for three (3) AHCP awards.

Infrastructure: In Q1, several PA and HMGP projects underway have requested, been approved for, and been paid DR funds



as reimbursement; other PA and HMGP projects continue to be reviewed for eligibility. The Q1 drawdowns are from the initial set of awards from May 2023 to assist three (3) HMGP and sixteen (16) PA projects with their Non-Federal share. PA projects, as a reminder, are entered into DRGR by activity type with NEMA acting as SR.

One-on-one technical assistance is delivered to subrecipients upon request to address immediate and emergent needs. Most requests are related to cross-cutting requirements. Risk assessment and pre-monitoring is underway for awarded PA and HMGP projects.

Planned progress.

DED will host HUD SFO and others for an onsite TA visit from April 23-25. This visit includes at least one project site tour for a funded project under AHCP-LIHTC in the HUD-MID (Douglas County).

DED will initiate voucher revisions to reallocate costs in 2024.

<u>Planned progress, Planning</u>: DED is in the process of launching a NOFO for Housing Resilience Planning activities. Launch is planned for Q2. Launch will include a technical assistance webinar for potential applicants and other interested parties.

No Action Plan amendments are anticipated in Q2. DED does plan to make updates to the DRGR Action Plan to reflect funding decisions for its existing funding programs, including the addition of activities under Projects. All such activities to be added are eligible under the current Action Plan.

<u>Planned progress, Housing</u>: In 2024 Q2, Small Rental applications will be accepted and reviewed. In addition, on May 9, 2024, the NIFA-DED joint application for 2025 9% LIHTC will be due; awards are scheduled for Q3.

In coordination with the awarded housing developers, DED is on track to execute funding agreements on three (3) AHCP-LIHTC awards in Q2.

<u>Planned progress, Infrastructure</u>: In Q2, the DED Compliance Team, in coordination with the DR Team, will deliver a Subrecipient Monitoring Entrance Meeting for NEMAâ¿s role in PA projects. Subrecipient monitoring for individual HMGP projects is anticipated in 2024 as projects move ahead.

In 2024 Q2, DED anticipates issuance of NOIAs to the two applicant jurisdictions for âiinon-FEMAâii projects seeking DR for cost-share of other funds to implement their flood mitigation projects.

Discussions of the use of ADCâiis are ongoing with subrecipients. DED continues to track those costs internally.

# **Activity Description:**

Risk Awareness and Resilience Planning will use CDBG -DR funding for the reduction of risk resulting from private levee failure and other flood risks and vulnerabilities. This activity will be carried out in coordination with the University of Nebraska-Lincoln.

Activities in support of Risk Awareness and Resilience Planning (RARP) will target areas with risk exposure, particularly those residential areas with risk exposure from private levees. The activities will target counties that received a disaster declaration under DR-4420 and focus on flood hazard vulnerabilities that led to flood damage under DR-4420. The overarching goal of the program is to promote comprehensive community resilience, resulting in a built environment that is more resilient to the impacts of natural disasters. The activities are intended to identify flood risk and vulnerabilities in counties that were declared under DR-4420. In support of these goals, DED may use the resulting adoption of local or regional plans, codes, and/or ordinances as scoring criteria in other CDBG-DR or other federal or state programs it administers.

# **Location Description:**

HUD-defined MID area is the primary focus, so 100% of this activity is allocated to the HUD-MID.

DED anticipates identifying and targeting three communties within the HUD-MID, one from each identified county, to carryout planning processes. Given the nature of flood and floodmapping, DED leaves open the possibility that some elements of these planning activities may spill over into state-defined MID areas. Should that occur, it will be so documented and any costs tracked accordingly.





# **Activity Progress Narrative:**

DED entered into an agreement with UNL to deliver Risk Awareness and Resilience Planning activities in 2023-Q4. Project activities are underway beginning in 2024-Q1. The initial perfomance term is two years. DED and UNL coordinated the initial/kick-off Project Advisory Committee meeting on January 26 to facilitate the successful implementation of planning activities. This meeting included further development of the stakeholder group list.

Several coordination and data gathering meetings with key stakeholder groups, including the NRDs situated in the HUD-MID, have taken place during Q1. DED, UNL, and NeDNR presented information about the project at session during the 2024 Annual Nebraska Planning and Zoning Administrators (NPZA) Conference on March 8, 2024. Future participation in this conference is planned to facilitate awareness of the project and further the underlying goals and objectives.

<u>Planned progress</u>: To assist in project management and recordkeeping, DED will create an Award in its GMS for the service agreement with UNL for delivery of Risk Awareness and Resilience Planning activities. Additional project meetings are scheduled for Q2, including at least one public meeting in Dodge County. The next project advisory committee meeting is scheduled for Q3. UNL is scheduled to present the first deliverable under the work plan in Q2.
