#### **Narratives**

#### **Disaster Damage:**

After record-setting low temperatures that created frost depths approximately two feet deep and ice on rivers and creeks in winter of 2018-2019, Winter Storm Ulmer, a bomb cyclone – or "winter hurricane," a term given to a rapidly intensifying storm – roughly equivalent in power to a Category 2 hurricane, moved across Nebraska between March 12 and 15, 2019. Recorded wind gusts during the cyclone approached 80 mph in many parts of the state and contributed to blinding blizzard conditions that closed highways and stranded motorists. Many roads and bridges, and other infrastructure, were damaged such that they were "out of service" or impassable for a considerable amount of time, causing remarkable disruption.

The bomb cyclone also brought heavy snow, blizzard conditions, rainfall, and above-freezing temperatures into much of the interior of the US. This part of the country already had significant snowpack on the ground due to above-average precipitation during the 2018-2019 winter season. Nebraska experienced its worst flooding event in 50 years between March and July 2019. As temperatures warmed in April and May 2019, the heavy snow and excessive rainfall from the 2018-2019 winter season contributed to rapid melting of ice and snow, resulting in flooded rivers and ice jams that breached levees, damaged infrastructure, and destroyed thousands of homes and businesses. The eastern side of the state was particularly impacted by flooding, resulting in fatalities, evacuations, and search and rescue missions.

In many areas, the flood damage was exacerbated by thick river ice breaking off in an atypically severe manner. Bridges were washed away by flooding or rendered impassable due to accumulated ice chunks.

#### **Recovery Needs:**

Grantees who receive an allocation through the CDBG-DR program are required to conduct an Unmet Needs Assessment (UNA) to assist in the identification and prioritization of critical unmet needs following a disaster and to identify long-term recovery efforts that will mitigate against future disasters. For DR-4420, the State of Nebraska's UNA, as carried out and completed for the Initial Action Plan, identified \$269,043,934 in unmet need, specifically \$55,637,821 in unmet housing need, \$196,163,422 in unmet infrastructure need, and \$17,242,691 in economic revitalization need. Throughout the State, recovery efforts have been taken and continue to be initiated for public and private housing and infrastructure facilities. During the development of the Initial Action Plan, local jurisdictions reported having completed repairs on homes that were damaged or destroyed as well as repairing infrastructure facilities. However, additional need remains.

As a result of the UNA process, Nebraska plans to establish funding opportunities in the following core sectors to assist in its disaster recovery:

- 1. Infrastructure
- 2. Housing
- 3. Planning

Nebraska's CDBG-DR program and funding opportunities are not designed or intended to create Program Income (PI) nor establish revolving loan funds (RLFs).

Low- and Moderate-Income (LMI) and Vulnerable Populations. Nebraska will prioritize activities under the housing programs that benefit LMI households, persons experiencing homelessness, and individuals requiring supportive housing, as identified in 24 CFR 91.315(e). Prioritization of vulnerable populations aligns with applicable Fair Housing requirements.

<u>Most Impacted and Distressed (MID) Areas</u>. Dodge, Douglas, and Sarpy counties will be the target for 80% of available CDBG-DR funding.HUD requires that 80% of CDBG-DR funds be allocated and spent in HUD-defined MID areas. HUD originally identified the MID areas as being the entirety of Sarpy County, zip code 68025 (Fremont, Inglewood, and Woodcliff) in Dodge County, and zip codes 68064 and 68069 in Douglas County (Valley and Leshara). Based on the UNA, Nebraska expanded the HUD-defined MID to include all of Dodge County and Douglas County.

Infrastructure Needs will be supported via the Infrastructure Match Program. Funding will be available to local jurisdictions for FEMA and non-FEMA projects. As the Initial Action Plan UNA and HUD's early assessments both indicated, DR-4420 generated catastrophic impacts to infrastructure, resulting in significantly higher losses in that core category than economic and housing needs. Infrastructure damage was widespread, with 84 out of 93 counties and four tribal areas impacted, reporting damage to roads, bridges, levees, dams and many other critical infrastructure facilities. To address the extensive infrastructure needs within the state, the state is prioritizing CDBG-DR funding under DR-4420 for infrastructure recovery. However, following the launch of the Infrastructure Match Program, designed to support local jurisdictions by making available CDBG-DR funding to pay the requisite local cost-share towards FEMA Public Assistance (PA) and Hazard Mitigation Grant Program (HMGP) projects, the actual amount requested by applicants was significantly less than anticipated. While there were over 300 applications for funding, nearly one-third were ineligible and over 80 percent of those projects determined initially eligible for DR funding were for amounts less than \$50,000. During the implementation process, other infrastructure projects not funded with FEMA were identified.

<u>Housing Needs</u> will be supported via the Affordable Housing Construction Program. As part of the Initial Action Plan, to determine how many housing units would require funding through the CDBG-DR program, DED conducted a data analysis to review the total number of homes served through existing State housing programs. DED estimated the total remaining unmet need in both the HUD MID and state MID areas to be 252 housing units. Upon the launch of the Affordable Housing Construction Program, the interest in funding to support construction of housing exceeded expectations. Thus, DED reallocated costs from undersubscribed programs to support that demand.

<u>Planning and Capacity Building</u>. Nebraska recognizes the importance of strong planning efforts to achieve equitable, effective, and sustainable long-term recovery. Therefore, has allocated funding for planning activities to further analyze and address flood hazard vulnerabilities that led to flood damages under DR-4420; and support an effective and resilient recovery from the disaster.

# **Overall Progress Narrative:**

Progress Overview OPR-2024 O2, March 31 - June 30, 2024.

DED hosted HUD SFO and others for an onsite TA visit from April 23-25. This visit includes at least one project site tour for a funded project under AHCP-LIHTC in the HUD-MID (Douglas County). DEDâ¿¿s CDBG-DR website is updated at least monthly with revised or updated program materials, all revisions to program

guides and chapters within the DR Manual are noted and acknowledged by version number and summary of changes is recorded in the respective Record of Changes to each document.

DED is still in the process of establishing a procedure for revising vouchers to reallocate costs initially charged against Admin (PACs) to the appropriate DRGR activity; this includes reallocating ADCs. DED is on track to meet program targets for LMI and HUD-MID investments. Program eligibility and resources in DRGR assist

in tracking these targets.

PLANNING: DED issued a NOFO for Housing Resilience Planning activities. Two technical assistance webinars are planned for potential applicants in early Q3. See additional progress information in the respective Activity narratives, including costs expended for Risk Awareness.

HOUSING: In 2024 Q2, DED accepted Small Rental applications (March 22-May 24) and initiated the review and scoring process for a total of nine (9) applications, representing \$15.7M in requests for 134 units, 120 of those units at or below 80% AMI; awards are scheduled for Q3. On May 9, 2024, the NIFA-DED joint application for 2025 9% LIHTC were due with awards scheduled for Q3; in April, DED conducted five (5) pre-application site reviews for those corresponding proposals requesting a total of \$10M in CDBG-DR, or \$2M each. DED executed funding agreements on three (3) AHCP-LIHTC awards, two (2) in April and one (1) in May.

Technical assistance for completing the due diligence process is ongoing for developers and projects selected through the HPP and LIHTC application processes in prior quarters. In addition, the DR housing program manager attended four (4) Focus Groups throughout May and June organized by NIFA for LIHTC applicants to discuss the latest QAP and any ideas for the upcoming 2026-27 OAP.

The regular technical assistance â¿¿check-insâ¿¿ with selected housing developers have proved successful and continue to be scheduled to support awarded projects pre-funding agreement and thereafter as needed to support compliance under the program.

INFRASTRUCTURE: Progress in Q2 was disrupted by additional federally declared disasters across the state; this included administrative delays. NEMA, DEDâ¿¿s coordinating partner and subrecipient for projects funded with CDBG-DR and FEMA PA, pivoted focus from DR-4420 long-term recovery to immediate response actions for those 2024 events. The Q2 planned

Payment request for PA projects is now scheduled for Q3, pending unforeseen issues. Refer to the HMGP activity narratives for progress reports and funds expended on those projects funded via individual SRAs. Following DEDâ¿¿s issuance of a NOIA, DED entered into a subrecipient agreement with Papio-Missouri River Natural Resources District to remove a sandbar obstruction for flood mitigation in Sarpy County (a HUD-MID area). The ERR process is underway. DED issued Nebraska Game and Parks a Notice of Intent to Award to relocate camp sites and shelter out of the floodplain at

Dead Timber State Recreation Area located in Dodge County (a HUD-MID area). DED Compliance Team initiated subrecipient monitoring for NEMA and DR-funded PA projects.

Discussions of the use of ADCs are ongoing with subrecipients; DED continues to track those costs internally.

PLANNED PROGRESS, Overall.

At the beginning of Q3, DED will open applications for Housing Resilience Planning activities, the last DR program to launch applications for funding. Several funded projects under Infrastructure and Housing are in full swing as construction season is well underway.

DED will begin drawing down ADCs via DRGR vouchers: voucher cover sheets and supplemental documentation shall tie those costs to the associated DRGR activities.

DED plans to make updates to the DRGR Action Plan to reflect funding decisions for its existing funding programs, including the addition of activities under existing Projects. All such DRGR activities to be added are eligible under the current Action Plan (APA3). Costs associated with updating the DRGR Action Plan are administrative in nature.

DED anticipates avecuting the SBA for the Dead Timber SBA

anticipated in 2024 as projects move ahead. In 2024 Q3, DED anticipates executing the SRA for the Dead Timber SRA project; executing an amendment for at least one HMGP project due to cost increases at the FEMA project level; and to continue processing payment requests for reimbursement of costs via DR funding as allowed under the program.

# **Activity Description:**

Risk Awareness and Resilience Planning will use CDBG -DR funding for the reduction of risk resulting from private levee failure and other flood risks and vulnerabilities. This activity will be carried out in coordination with the University of Nebraska-Lincoln.

Activities in support of Risk Awareness and Resilience Planning (RARP) will target areas with risk exposure, particularly those residential areas with risk exposure from private levees. The activities will target counties that received a disaster declaration under DR-4420 and focus on flood hazard vulnerabilities that led to flood damage under DR-4420. The overarching goal of the program is to promote comprehensive community resilience, resulting in a built environment that is more resilient to the impacts of natural disasters. The activities are intended to identify flood risk and vulnerabilities in counties that were declared under DR-4420. In support of these goals, DED may use the resulting adoption of local or regional plans, codes, and/or ordinances as scoring criteria in other CDBG-DR or other federal or state programs it administers.

# **Location Description:**

HUD-defined MID area is the primary focus, so 100% of this activity is allocated to the HUD-MID.

DED anticipates identifying and targeting three communties within the HUD-MID, one from each identified county, to carryout planning processes. Given the nature of flood and floodmapping, DED leaves open the possibility that some elements of these planning activities may spill over into state-defined MID areas. Should that occur, it will be so documented and any costs tracked accordingly.



# **Activity Progress Narrative:**

In 2024 Q2, DED created an Award in its GMS for the service agreement with UNL for delivery of Risk Awareness and Resilience Planning activities. With this action, UNL will submit its Payment Requests under the service agreement via the GMS. 1 public project meeting held in Fremont (Dodge County) on April 1 at their Keene Memorial Library from 6-8PM C. Project meetings with stakeholders continued, including meeting with USACE and economic development organizations. In May, UNL submitted their first deliverable, 'Community Flood Risk, Vulnerability, Mitigation, and Adaptation Report for the HUD Most Impacted and Distressed Areas for Nebraska DR-4420'.
