Overview & Authority

- This is a federal program.
- United States Department of Housing and Urban Development (HUD) includes the Office of Community Planning and Development (CPD).
- Title 1 of the Housing and Community Development Act of 1974 (HCDA); Public Law 93-383, as amended; and 42 U.S.C.
 5301 et seq. authorize HUD to make grants under the Community Development Block Grant (CDBG) program.
- The primary objective of HCDA is the development of *viable communities*.



Overview & Authority, con't.

- HUD CPD provides annual grants on a formula basis to states, cities, and counties to develop *viable communities* by providing, *principally persons of low- and moderate-income*:
 - Decent housing,
 - A suitable living environment, and
 - Expanded economic opportunities
- State CDBG Programs make funding available to units of local government (UGLGs).
- UGLGs are responsible for:
 - Prioritizing the types of eligible activities they apply for,
 - Local citizen participation,
 - Carrying out funded activities, and
 - Complying with federal and state requirements.



Overview & Authority, con't.

- DED administers Nebraska's State CDBG Program, adhering to the applicable federal and state requirements, and HUD guidance.
- DED works directly with the HUD through their Omaha CPD Field Office.
- Under the State CDBG Program, Nebraska is the "Grantee" and is responsible for:
 - Developing the Consolidated Plan;
 - Designing the CDBG Program within statutory and regulatory parameters;
 - Setting priorities and identifying activities to meet them;
 - Distributing funding according to the method of distribution (MOD);
 - Establishing financial management, recordkeeping, reporting, monitoring, audit, and closeout procedures for programs; and
 - Ensuring compliance by those carrying out funded activities.



Introduction to CDBG Funding

HUD Office of Community and Planning, with limited exceptions, administers the State CDBG Program and CDBG Entitlement Program through its Field Offices.








Congress appropriates funding using their funding formula for CDBG HUD awards allocations of funding to CPD Formula Grantees Grantee submits Consolidated Plan and/or Action Plan to HUD for approval

Grantee implements approved Action Plan



Introduction, con't.

As the HUD Grantee, DED is responsible for deploying investments of CDBG funding via its Method of Distribution.



From time to time, as Grantee, DED may submit Action Plan Amendments to respond to evolving needs and/or priorities under the CDBG program. NEBRASKA

Program Schedule, Key Dates

This schedule represents a year when Nebraska's Consolidated Plan is due to HUD for approval. It also assumes there are no delays at the federal level. Depending on date of appropriation from Congress, this timing may be delayed at the federal level. Grantees cannot submit their Action Plans to for HUD approval without the formula allocations.

- Five-Year Consolidated Plan to HUD: 45 days before start of program year
- Annual Action Plan to HUD: 45 days before start of program year
- Start of Program Year: July 1
- CAPER to HUD: 90 days after end of program year



Timing & Method of Distribution

Annual Action Plan 30-day Public Comment: April/May

- Public participation process
- Method of Distribution
- Program goals and objectives

CDBG Application Guidelines: May/June

- Eligibility
- Funding opportunities
- Application scoring and selection

Program Year, Key Dates

- Start Date: July 1
- Competitive Application Cycle Closes: September
- Award Announcements (competitive cycle): November
- Environmental Clearance/Release of Funds: February
- Period of performance: 30 months

*Depending on date of appropriation from Congress, this timing may be delayed at the federal level. Grantees cannot submit their Action Plans to for HUD approval without the formula allocations.



Eligible Applicants

- Every Nebraska county or incorporated municipality <u>not</u> designated as CDBG 'Entitlement Community' is eligible to apply to the State CDBG Program.
- Entitlement Communities are <u>not</u> eligible to apply to a State CDBG Program because they receive funding directly from HUD. In Nebraska, this includes:
 - Bellevue
 - Grand Island
 - Lincoln
 - Omaha




National Objectives

Every CDBG project must meet a National Objective:

- 1. Benefiting low- and moderate-income (LMI) persons
- 2. Aid in the prevention or elimination of slums and blight (SB)
- Meets community development needs having a particular urgency or urgent need (URG) that the unit of local government is unable to fund on its own or obtain other sources of funding*

*Urgent Need is seldom used in the implementation of State CDBG Programs due to the documentation requirements.





Over Nebraska's HUD-approved Con Plan period, at least 70% of funding must benefit **low- and moderate-income individuals** during allocated years. NFBRASKA

LMI National Objective

- LMA Low/Moderate Income on an Area Basis area is primarily residential
- LMC Low/Moderate Clientele specific group, not by area
 - Activities that exclusively benefit a clientele who are generally presumed by HUD to be principally LMI, including:
 - 1) Abused children 5) Illiterate adults
 - 2) Elderly persons 6) Persons living with AIDS
 - 3) Battered spouses 7) Migrant farm workers
 - 4) Homeless persons
 8) Adults meeting Bureau of Census' definition of severely disabled adults
 - LMJ Low/Moderate Income Jobs

Jobs are held by or made available to low-moderate income persons



Slum and Blight National Objective

- Slum and Blight focuses on activities that create a change to the physical environment of a deteriorating area or spot.
- There are two ways to meet Slum and Blight
 - SBA Area Basis
 - SBS Spot Basis



Application Review & Selection

Step 1 Applications reviewed for threshold compliance **Step 2** Qualified applications move to Review Teams

Step 3 Applications scored and ranked

Step 4 Applications recommended for award

Step 5 Announcement of status of application.

Application review is completed by DED staff.

Award Implementation by UGLG

Start Date Notice of Approval Months 0-1 CDBG Agreement (Period of Performance established)

Months 0-3 Environmental Clearance & Release of Funds Months 4-24 Carry out Funded Activities and Reporting Requirements

Months 24-30 Closeout

An awarded unit of local government (UGLG) may engage a third-party to support the implementation of their award. In all cases, **the awarded UGLG is responsible for award implementation**, including but not limited to financial management, recordkeeping, and record retention.
