First Amendment (Substantial) Overview to State of Nebraska CDBG-DR Action Plan



The following slides are an overview of the proposed changes to the Action Plan that involve a "substantial" change, including:

- Affordable Housing Construction Program (AHCP)
- Homeowner Assistance Program (HAP)

Why the changes?

- Improve implementation of the AHCP by more fully recognizing the role of for-profit developers in executing affordable housing projects involving Low Income Housing Tax Credits (LIHTC)
- Clarify eligibility requirements for non-profit applicants under HAP to potentially expand the pool of applicants.

Total allocations defined within the approved Action Plan will remain the same under the First Amendment (Substantial).

DED will undertake necessary revisions to policies and procedures to implement changes made by this Substantial Amendment.

Description	"For more development activities, DED will directly award funds (typically in the form of a loan) to developers, including non-profit or for-profit entities. In other cases, local government, PHA, and nonprofit applicants may be designated as subrecipients. Subrecipients will operate as the primary administrative entity of their respective grants from DED, in turn sub-awarding CDBG-DR funds to the actual ownership entity developing the housing (typically in the form of a loan."

Description	Revised to reflect that funding will also be administered to applicants that include for-profit developers of rental housing. Note that for-profit development entities will be managed in a process that is distinct from structures designated for Subrecipients. For-profit development entities will be referenced as "applicants," even if they are selected for funding under the Affordable Housing Construction Program.
Reasoning	Improve implementation of the AHCP by more fully recognizing the role of for-profit developers in executing affordable housing projects involving Low Income Housing Tax Credits (LIHTC)

Homeownership Assistance Program

Summary of Changes	
Description	Under Eligible Applicants, clarify non-profit eligibility by removing requirement that the non-profit is approved to provide housing counseling, homeownership education, and homebuyer programs.
Reasoning	This change allows for a non-profit applicant to apply under HAP and refer beneficiaries to HUD-certified agencies for housing counseling.

	The current CPP is here . HUD has already acknowledged this revised CPP.
