The State of Nebraska Department of Economic Development (DED) is hosting two informational community meetings on November 29 discussing the Community Development Block Grant – Disaster Recovery (CDBG-DR) programs set forth in the State's CDBG-DR [Action Plan](#). DED is committed to obtaining broad community input in developing and administering the CDBG-DR programs to address unmet priority needs and inform overall program design. These virtual meetings are intended to provide an overview of each of the CDBG-DR programs and solicit feedback.

The first meeting, scheduled from 2:00-3:00pm CST, focuses on establishing a landscape for targeted stakeholders and potential applicants to each of the CDBG-DR programs. Targeted stakeholders include:

- public agencies;
- municipal elected officials;
  - tribal nations;
  - long-term recovery groups;
  - advocacy organizations for the homeless, elderly, individuals and families with disabilities, racial and ethnic populations, and low- and moderate-income citizens; and
  - special interest groups, including non-profit organizations, philanthropic organizations, community and faith-based organizations, continuums of care, real estate developers, housing advocacy organizations, commercial and industrial interests.

The second meeting, scheduled from 5:15-6:15pm CST, is intended to increase public awareness and provide additional information on how these CDBG-DR programs will impact Nebraska communities.

Both meetings are open for anyone to attend and provide feedback to further enhance the CDBG-DR programs.
